## **Immunization Record Correction Form**

Manitoba Health, Seniors and Active Living (MHSAL) has developed an Immunization Record Correction Form
(attached) that health care providers are encouraged to use to report an issue (e.g. duplicate, incorrect or
missing immunizations) with their client's immunization record. The form is to be completed and faxed to your

## **Reminder of Immunization Program Changes**

- In 2015/16 MHSAL introduced Immunization schedule efficiencies to improve Manitoba's immunization program.
   Please ensure that you are immunizing your clients based on the current immunization schedule and using the correct products. An updated Routine Immunization Schedule has been included and can be located at <a href="http://www.gov.mb.ca/health/publichealth/cdc/div/schedules.html">http://www.gov.mb.ca/health/publichealth/cdc/div/schedules.html</a>
- Effective September 2016, healthy males born on or after January 1, 2002 are eligible for Human Papillomavirus (HPV) vaccine. This will be offered as part of the school immunization programs in Grade 6 as well as in Grade 8 or 9 (3 year catch-up program).
  - For healthy females and males under 15 years of age, 2 doses are recommended. For those who missed the school-based program, a 3 dose schedule is recommended, unless the first dose of vaccine was administered before the age of 15.

## 2016/17 Influenza Program Reminders and Updates

- Providers/facilities can place their flu and/or pneumo vaccine order with MHSAL until September 15<sup>th</sup>. The order form is located: http://www.gov.mb.ca/health/publichealth/cdc/protocol/influpnevcorderform.pdf
- All flu/pneumo vaccine orders will be shipped according to the following schedule:
  - 1. Hospitals, personal care homes (PCHs) and First Nations communities
  - 2. Providers/facilities with Client ID ending in 7 to 9
  - 3. Providers/facilities with Client ID ending in 0 to 3
  - 4. Providers/facilities with Client ID ending in 4 to 6
  - 5. Providers ordering after September 15, 2016
- Please visit the Seasonal Flu Vaccine Distribution and Supply website that will be updated accordingly to indicate an approximate date of when providers/facilities may expect to receive their shipment. (www.gov.mb.ca/health/flu/distribution.html)
- As regular vaccine orders may be delayed while the influenza vaccines are being shipped please ensure you
  have sufficient supply on hand to last until October/November that can be stored appropriately.
