

# 1999 MANITOBA ESTIMATES OF REVENUE

FOR THE FISCAL YEAR

ENDING MARCH 31, 2000

AS PRESENTED TO THE

FIFTH SESSION,

**THIRTY-SIXTH LEGISLATURE** 



### INTRODUCTION

The Manitoba Estimates of Revenue for the Fiscal Year Ending March 31, 2000 detail the revenue projections of the government as presented in The 1999 Manitoba Budget. Estimates of expenditure for the same period are detailed in a separate document, Manitoba Estimates of Expenditure for the Fiscal Year Ending March 31, 2000.

#### **Prior Year Estimates of Revenue**

In order to make year-over-year comparisons meaningful, adjustments to the previous year's estimates figures may be necessary. These adjustments may reflect organizational changes, as well as any other adjustments that may be required to ensure comparability. Normally, the total of the previous year's estimates of revenue do not change as a result of these adjustments.

#### **Categorization of Revenues**

Revenues are grouped by the three major sources: Taxation, Other Revenue and Government of Canada. Within each of these major sources, additional information is provided on the department responsible for collection, and the type of revenue.

#### 1997 Flood

Total expenditures that will be incurred by Manitoba in 1999/2000 as a result of the 1997 flood are estimated to be \$68.8 million.

The federal government will contribute towards 1997 flood costs under two different programs, general disaster assistance and flood proofing. Total federal contributions in 1999/2000 are estimated to be \$29.7 million.

The 1999/2000 net provincial cost of the flood is being funded by a transfer from the Fiscal Stabilization Fund. An amount of \$37.2 million has been included in the 1999/2000 estimates of revenue to reflect this transfer.

The following summary identifies where flood related expenditures and revenues have been included in the 1999/2000 estimates.
