In accordance with the Manitoba Environment Act (C.C.S.M. c. E125)

THIS LICENCE IS ISSUED TO:

**The Province of Manitoba Represented by  
The Minister of Highways and Transportation:  
The "Licencee"**

for the construction of the Development being an access road beginning at the God's River Airstrip and extending to the God's River Lodge, and a winter road beginning at the God's River Airstrip and extending to a borrow area located a distance of 4.5 km. to the north subject to the following specifications, terms and conditions:

1. The Licencee shall construct the Development in accordance with the alignment, configuration and design as described within the Environment Act Proposal of the *God's River Airport Access Road and Winter Road to Borrow Area*, dated February 1993.
2. The Licencee shall, during construction, adhere to the Manitoba Department of Natural Resources guidelines titled *Recommended Fish Protection Procedures for Stream Crossings in Manitoba*.
3. The Licencee shall, prior to spring breakup, remove temporary stream crossings associated with Development.
4. The Licencee shall, during construction, salvage and utilize locally merchantable timber from the Development.
5. The Licencee shall, during construction, maintain where feasible, a 100 meter separation between the access road right-of-way and the God's River. The Licencee shall, prior to construction, reach an agreement with the Natural Resources Officer on mitigation to be used in all areas where the separation between the access road right-of-way and the God's River shall be less than 100 meters.

6. The Licencee shall, prior to construction and in consultation with the Natural Resources Officer, identify all eagle nests located within 100 meters from the edge of the access road right-of-way. The Licencee shall, prior to construction, reach an agreement with the Natural Resources Officer on the mitigation to be used for eagle nests identified within the 100 meters from the edge of the right-of-way.
7. The Licencee shall, upon completion of construction, backslope borrow pits related to the Development at a slope of 3:1.
8. The Licencee shall, during the spring of 1993 and as soon as field conditions permit, arrange to have the Development field inspected by the Historic Resources Branch, Manitoba Department of Culture, Heritage and Citizenship. All significant heritage resources identified by the field inspection shall be mitigated in accordance with the requirements of the Historic Resources Branch, Manitoba Department of Culture, Heritage and Citizenship.
9. The Licencee shall, during construction, ensure that all fuel storage areas established for the construction of the Development are located a minimum distance of 100 meters away from all lakes and streams, and shall comply with the requirements of *Manitoba Regulation 97/88R* respecting *Storage and Handling of Gasoline and Associated Products Regulation*.
10. The Licencee shall, during construction, dispose of all sewage and sullage from sanitary facilities in accordance with *Manitoba Regulation 95/88R* respecting *Private Sewage Disposal System and Privies*.
11. The Licencee shall, during the full term of the construction of the Development, cleanup and deposit all debris from the construction site at a Waste Disposal Ground operating under the authority of a permit issued pursuant to *Manitoba Regulation 150/91R* respecting *Waste Disposal Grounds*.
12. The Licencee shall, during construction, ensure that any construction camps related to the Development comply with all requirements under *Manitoba Regulation 35/88R* respecting *Industrial and Construction Camp Regulation*.
