Barb Gamey co-founded Payworks, Inc. and serves as its chief executive officer. Gamey has overseen the strategic direction and development of the company since its inception. She served as president of Payworks, Inc. She has 15 years of experience. She has been honoured with awards for her entrepreneurial work, most recently when she was named by Women of Influence Inc. as the winner in the Momentum Award at the 2012 RBC Canadian Women Entrepreneur Awards (CWEA). The company was founded in 2000 and is based in Winnipeg with additional offices in Toronto, Vancouver, Victoria, Kelowna, Calgary and Edmonton.
