

**How can the government further encourage private sector growth and leadership in our province's economy and in the north?**

**Responses**

get rid of the payroll tax. do NOT put in a carbon tax. lower taxes will make MB a haven for companies after the mess in Ontario and the NDP in Alberta.

Focus support on entrepreneurial/growth businesses rather than small lifestyle businesses. Remove payroll tax as it inhibits business growth. Ensure strong links for training on new business opportunities/entrepreneurship in the North.

Remove the payroll tax

I would continue to provide some support, but also reduce the amount of support offered. I would examine existing programs that have been extremely successful and are cost neutral, and invest in those. Any other program investment should be limited.

Small businesses, such as my own, pay a ridiculous amount in taxes. Offering small businesses grants and making them easier to access and receive would greatly increase the economy by making starting your own business a reality that is out of reach for a lot of people, and the money would be put right back into the city in a relatively short time with the taxes we generate and pay.

Leverage capital / VC funding with federal funds to support the creation of strategic clusters.

removing income tax would help businesses grow.

Governments have a pretty poor track record as providers of capital. Right now, there is more capital available in the world more cheaply than ever before in history; capital holders are desperate to find profitable opportunities to invest. Yet the province of Manitoba is going to judge what appear to be promising businesses better than all private capital holders? Sounds like a way to throw money into failing business plans or cronies' pockets, actually.

\$500M doled out to small business? That's great if you can afford it but if you can't.... then you can't. How much bang for the buck have you gotten out of this expenditure in the past? Again, there can be customized approach to supporting small businesses but there has to be a significant benefit or a very solid justification with an expectation of return. The bar needs to be set high for applications of this nature. Private industry should be apart of this picture.

Verifiable tax incentives. If you want to spend my tax dollars on a private company let them prove they need it and attach conditions.

Make Manitoba competitive tax wise with other provinces to keep our best people in the province and want to grow their companies.

Lower business taxes and red tape.

Some programs are intended to boost the knowledge and skills of small business owners; however, "capacity-building" can be a real, powerful phenomenon, or it can be window-dressing for a bunch of self-occupied, self-justifying departmental administrators. The success of such programs depends in large part on the competence, motivation and energy of both the administrators and the recipients. Hire only the best.

Capital in the form of business loans should be managed through banks, not government.

Tax breaks and infrastructure supports (such as those intended to create innovation parks) are time-honoured ways of supporting businesses both small and large.

The programs should not be putting more money in administrators' pockets than in small business's pockets. The outcomes need to be a lot better than break-even, Measure the results of these programs. If we spend more than we get back in employment, tax revenues and other measurable benefits, then find other ways to support small business.

Support immigration.

Fund initiatives that provide opportunities for private sector / entrepreneurs to work together with the public sector to address some of the 'wicked issues' through a social innovation framework (including northern economic growth). Address policy barriers that restrict innovative business model and products. Support entrepreneur / small business mentorship and training. Support seed funding without complex application processes typically found within Social Impact Bond.

we need to focus on helping large employers be successful here - we have lost too many head offices. It takes a lot of small businesses who pay lower wages to replace one big employer. Very few small businesses actually make it to larger successful businesses

Reduce the price disadvantage to do business in the north. The change in prices and opportunities for services in the north is severely lower than that in the south. Teach entrepreneurship and leadership classes in high school to plant the seeds of business ownership. I believe the interest of Indigenous communities to take over things like the railway to Churchill is very positive and would be an appropriate investment - but it should also receive Federal support, as having an Arctic port (and transportation to it) is in the entire country's interest. I would potentially reduce small business support, but would not cut it entirely.

Tie provincial infrastructure funding to local investments in regional economic development initiatives; if local municipalities refuse to invest in local economic development, why invest in them?

Support for small scale farming to provide for the food needs of northern communities locally instead of using costly imported foods. This could include conventional and green house growing which could use electricity generated in the north to improve yields. The government can encourage this through small grants for start up farms and by including local agriculture in the school curriculum.

Rather than allowing the money to be wasted hold the person accountable if the business fails the person would be on the hook for the money. The screening process should be more indepth. The province needs to make good investments not bad ones.

Take ownership of northern industries and natural resources.

Low taxes stimulate private sector spending and market growth.

By creating a well-educated and healthy workforce.

Maintain the existing Norther Healthy Foods Initiative budget and consider increases to scale up existing initiatives, expand into other Northern communities, and achieve new revenues through reductions in health costs and job creation.

Government can work with the private sector to offer tax incentives to attract and retain companies. This should be fully explored. Also we need a strong federal partner in the North. A plan that involves meaningful input and in a true partnership with First Nations and the federal government should be developed for Northern Manitoba.
