#### PUBLIC NOTICE SPECIAL SURVEY ACT MANITOBA

A Special Survey has been made in River Lot 43 Parish of St. Boniface. If a written objection is received, the hearing may be re-scheduled. Complainants will be contacted by The Municipal Board in that regard. If no objection is received the Plan of Special Survey will be submitted to the Registrar General for approval and registration.
