THIS LICENCE IS ISSUED TO:

## The Local Government District of Park and the Rural Municipality of Clanwilliam: "the Licencee"

for the construction and operation of the Development being a bridge crossing on Whirlpool Creek south of SW 2-19-18W between the Local Government District of Park and the Rural Municipality of Clanwilliam, subject to the following specifications, limits, terms and conditions:

## Specifications. Limits. Terms and Conditions

- 1. The Licencee shall construct and operate the Development in accordance with the Environment Act Proposal dated May 11, 1993 and a supplementary letter dated April 21, 1994 and addressed to Manitoba Environment.
- 2. The Licencee shall, prior to commencing construction, submit design and construction documents for the Development for the approval of the Director.
- 3. The Licencee shall not undertake instream construction activities associated with the Development between April 1 and June 15 of any year.
- 4. The Licencee shall ensure that the Development is constructed in accordance with the Manitoba Natural Resources publication Recommended Fish Protection Procedures for Stream Crossings in Manitoba.
- 5. The Licencee shall contact the Regional Fisheries Manager of Manitoba Natural Resources advising of the anticipated construction schedule for the Development at least two weeks before beginning construction.
- 6. The Licencee shall take appropriate measures during the construction of the Development to ensure that exposed soil does not enter Whirlpool Creek as a result of construction activities or erosion.
- 7. The Licencee shall revegetate soil exposed during the construction of the Development with native or introduced grasses or legumes.
- 8. The Licencee shall dispose of all construction debris at an approved Waste Disposal Grounds.

- 9. The Licencee shall ensure that all waste oil products generated by the machinery used in the construction and operation of the Development are collected and disposed of in accordance with applicable Manitoba Environment and legislative requirements.
- 10. The Licencee shall ensure that fuel storage areas established for the construction and operation of the Development shall comply with the requirements of Manitoba Regulation 97/88R respecting Storage and Handling of Gasoline and Associated Products.

## Revocation

If, in the opinion of the Director, the Licencee has exceeded or is exceeding the limits, or has not complied or is not complying with the specifications, terms or conditions set out herein, the Director may revoke this Licence either temporarily or permanently.
