AN ORDER OF THE CLEAN ENVIRONMENT COMMISSION

UNDER THE CLEAN ENVIRONMENT ACT

RE: THE CLEAN ENVIRONMENT COMMISSION and CANADIAN INDUSTRIES LIMITED, Applicant,

WHEREAS

pursuant to the provisions of The Clean Environment Act, Mr. J.D. McIrvine of Canadian Industries Limited, Montreal, Quebec submitted an application to The Clean Environment Commission to prescribe limits in connection with the operation of a Mines Reagent Plant located in Township 78 Range 3 WPM outside of the limits of the City of Thompson in the Local Government District of Mystery Lake, Manitoba

AND WHEREAS

no representation was made to the said Commission by any person who is, or is likely to be, affected by an Order of the said Commission prescribing limits in connection with the said operation,

AND WHEREAS

the said Commission considered the application on the 3rd day of December, 1974,

IT IS HEREBY ORDERED THAT

- The Applicant shall ensure that the quality of the various vapours and gaseous emissions to the air arising from the said operation are such that
 - (a) in any residential area or area zoned residential off the site of the said operation odour is not detectable when the suspect air is diluted with one equal volume of odour-free air; and
 - (b) in any industrial area or area zoned industrial off the site of the said operation odour is not detectable when the suspect air is diluted with six volumes of odour-free air;

- 2. The Applicant shall ensure that all solid wastes arising from the said operation are:
 - (a) placed in impermeable containers and sealed; and
 - (b) disposed of at the City of Thompson waste disposal ground or at such other location or in such other manner as may be approved or prescribed;

to the satisfaction of the Environmental Management Division of the Department of Mines, Resources and Environmental Management,

- 3. The Applicant shall ensure that all liquid wastes other than domestic sewage and sullage, arising from the said operation, are retained on the site of the said operation in an impermeable container or receptacle and
 - (a) analyzed for the presence of contaminants as may be directed or required by the said Environmental Management Division; and
 - (b) either re-absorbed in the said operation or otherwise disposed or as directed or required by the said Environmental Management Division.

*Note with respect to odour as determined in ambient air off the site of the operation

- 1. A single testing for the presence of detectable odour is deemed not conclusive unless confirmed by a second test made within the period of not less than 15 minutes and not more than 60 minutes after the taking of the first test.
- 2. Odour to be measured with a Scentometer by the Environmental Management Division of the Department of Mines, Resources and Environmental Management of by another agency authorized by the Minister of the said Department for this purpose.
