

Information Bulletin - Supplementary Pesticide Use Permit Guidelines



These guidelines apply to Pesticide Use Permits issued under *The Environment Act*.

IN ACCORDANCE WITH AMENDED MANITOBA REGULATION 94/88R UNDER CHAPTER E125 OF THE ENVIRONMENT ACT A PESTICIDE USE PERMIT is required for pesticide applications:

- a) on or in a body of water that is not wholly contained within the person's own property; or
- b) on private property to which the public normally has access for recreational purposes (includes golf courses, fair grounds, parks, campgrounds, lodges and cottage subdivisions); or
- c) for or on behalf of:
 - i) government departments
 - ii) Crown corporations
 - iii) municipal corporations
 - iv) school divisions; or
- d) on Crown lands or rights-of-way, for an individual other than a farmer or a corporation other than a farm corporation; or
- e) for an association of the cottage owners in a cottage subdivision.

APPLICATIONS FOR PERMITS

Applications for permits shall consist of:

- a) the completed permit application form submitted to the department at least 30 days prior to the intended date of use of the pesticide; and
- b) covering letter with any additional information.

APPROVED APPLICATIONS

Applicants will be advised within 30 days, in cases where the application is not approved only, of reasons for non-approval or of what additional information is required before approval can be contemplated. Approved applications will be assigned a permit number and a permit signed by the Director will be issued. Any terms and conditions deemed necessary will appear on the permit.

AMENDMENTS

Amendments to the registration form may be made by the applicant in writing prior to the date of the intended use of the pesticide giving the reasons for and the nature of the change. The Director may impose such terms and conditions on the use-permit as he/she deems necessary.

PUBLIC NOTIFICATION

Public notification is required by the applicant at the time that the registration form is submitted to the department. This notification is required in one or more issues of a newspaper/news bulletin that has general circulation in the community in which the pesticides are to be used stating:

- a) the reasons for the control program;
- b) the names of the pesticides to be used;
- c) the approximate dates of the proposed use;
- d) the approximate areas to be treated with pesticides; and
- e) **a statement that any person may, within 15 days after the notice is published, send a written submission to the department below, regarding the control program or register with the department their written objection to the use of pesticide next to their property.**

SAMPLE OF NEWSPAPER ADVERTISEMENT

PROPOSED MUNICIPAL PESTICIDE PROGRAM

Public Notice is hereby given that the Rural Municipality of _____ intends to conduct the following Pesticide Control Programs during 200__:

1. To control noxious weeds on road allowances within the Municipality. The projected dates of application will be from May 1, 200__ to October 1, 200__. The herbicides to be used include:
 - 2-4-D amine
 - Picloram
 - Glyphosate
 - Dicamba
2. To control rats at the waste disposal grounds at various times during the coming year using the rodenticide Brodifacoum.
3. To control the following insect pests including grasshoppers, mosquitoes, elm bark beetles, cankerworms, etc. The proposed dates of application for these programs will be from May 1, 200__ to October 31, 200__. The insecticides to be used include:
 - Dimethoate
 - Malathion
 - Bacillus thuringiensis

The public may send written submissions or objections within 15 days of the publication of the notice to the department below.

**INSTRUCTIONS FOR COMPLETING
THE PESTICIDE USE PERMIT APPLICATION FORM**

1. APPLICANT

Applicant refers to the person applying for the permit, who will be ultimately responsible for the administration of the programs carried out under the permit. Indicate the organization represented (eg. Department, Municipality, Weed District, etc.).

2. APPLICATOR

Applicator refers to the person, company or agency which will apply the pesticides on behalf of the permit holder. Enter "to be selected" if the choice of the applicator has not been made. Each program must be directly supervised by a person holding a commercial applicators licence. The only exception is where pesticides classified as "Domestic" are used exclusively.

3. LOCATION OF SPRAY PROGRAM

- a) Enter the name of the municipalities or LGDs involved in the program.
- b) If the program is in an urban area indicate the name of the city, town or village.
- c) If the program takes place in an area not included in the above (eg. park campground, etc.), enter the information in the third section.

4. PURPOSE OF SPRAY PROGRAM

State what type of programs are to be carried out under the permit. If desired, permit applications can be submitted separately for each program. For example insect control programs may be applied for separately from weed control programs. Indicate the specific intent of each program. Where possible identify target species. For example: dandelion control along road allowances, mosquito larviciding in stagnant water.

5. PROJECTED DATES OF PROGRAM

Please indicate approximate dates for commencement and completion of the pesticide program.

6. PESTICIDES TO BE USED IN PROGRAM

a) **Pesticide**

List each pesticide and formulation proposed for use in the programs.

b) **Pest Control Products Act No.**

Refers to the number assigned to the specific pesticide by Health Canada, under the Pest Control Products Act. Every pesticide registered for use in Canada will have a PCP No. on the label.

c) **Target Species**

List the species of which the identified product is targeted for use.

d) **Application Method**

Describe the equipment to be used in the spray programs (eg. back pack sprayer, truck mounted spray boom, aircraft, etc.).

7. PLEASE SIGN AND DATE APPLICATION

8. APPLICATION FEE

An Application Fee of **\$250** is charged for each permit applied for. A cheque, payable to the Minister of Finance, for the appropriate fee must accompany each Pesticide Use Permit Application at the time the Application is filed.

9. ADDITIONAL INFORMATION MAY BE PROVIDED ON A SEPARATE SHEET.
