Hi Rafiqul,

I'm not sure if it's too late to add additional comments, please see the following:

The Lands Branch notes that the proposal has no mention of nutrient management with respect to the effluent discharged. The proposed discharge route although not specifically identified in the proposal indicates the effluent will travel ten plus miles of drainage ditch (2nd and 3rd order) before it enters Sturgeon Creek. With that length of travel uptake of effluent nutrient by the existing ditch vegetation would be anticipated. It would have been appropriate for the proponent to have provided details in regards to nutrient management prescriptions for the effluent as the drainage waters eventually enter Lake Winnipeg.
