### Mr. Webb,

I reviewed the above noted EAP for upgrading of the water treatment plant at Kenton. (ODW System code No. 102.00). TheEAP proposes to discharge the process wastewater to a drain which flows to the Oak River and then to the Assiniboine River. The point of discharge is upstream of the water intake in the Assiniboine River for the City of Brandon water system. As such, ODW recommends that a provision be added to the Licence that if a major spill of deleterious materials (fuel etc.) into the river occurs, the Brandon water treatment plant operators be notified immediately.

Also, it should be noted that a Permit to Construct will need to be issued by ODW before construction of the proposed work begins. The Permit application package should be submitted to the Approvals Unit of ODW as soon as the construction drawings and specifications are finalized.

Apart from these points, ODW has no other concerns with the EAP. I trust this is satisfactory, but if you have any questions, please call. Regards,
