### Hi Bruce.

Fisheries Branch has reviewed this request to upgrade the Water Treatment Plant at Thicket Portage. Raw water is drawn from Landing Lake via the existing intake line. Backwash waste will be directed to an underground storage tank with the capacity to hold the backwash from one cycle prior to discharge (allow for solids to settle). The outfall line from the concrete tank discharges into an existing drainage course (~1km in length) which leads to Landing Lake. The rinse to waste stream that occurs immediately after a backwash cycle will bypass the concrete storage tank and be discharged directly into the drainage course as it is considered clean with no chemical additions. The proponents indicate that there is the potential for chlorine residual to be released into the natural environment and for the drainage course to freeze over in the winter months. To mitigate against the discharge pipe freezing they plan to use insulated pipe and surround it with insulation. They will try time the backwash and rinse waste cycles with mild winter weather and if drain freeze up occurs not local operators will be provided with the tools to break up ice formation in the drainage course.

As long as the backwash effluent is tested prior to release and meets or exceed Manitoba Water Quality Standards, Objectives and Guidelines and the proponents implement the mitigation measures (erosion and sediment control measures for excavation, fuelling away from surface water, etc) they've identified in the proposal any fisheries concerns should be addressed. They do not indicate whether the raw water intake pipe is screened. Landing Lake is a fish bearing water and the intake should be screened according to the Freshwater Intake End-of-Pipe Fish Screen Guideline. This does not appear to be a condition on their Water Rights Licence can it be included as a condition of their Environment Act Licence.
