
Hydrologic Forecasting has reviewed the subject Environmental Act Proposal (EAP) and has the following comments:


The proposed potential booster station site, as identified in the EAP Detailed Drawing, is located within the Red River Valley Designated Flood Area (RRVDFA). Aerial photographs (attached) taken during the 1997 and 2009 Red River Floods indicate that the property was completely inundated during both flood events.

Natural ground elevations at the site, obtained by LiDAR, range from approximately 236.5 to 237.1 metres (776 feet to 778 feet), G.S. of C. Datum. The 1997 flood level, the equivalent of a 100 year flood event, reached an elevation of approximately 239.0 metres (784.2 feet), G.S. of C. Datum at this location. The corresponding Flood Protection Level at this location is approximately 239.6 metres (786.2 feet) G.S. of C. Datum.

Hydrologic Forecasting has no objections to the EAP for the purposes indicated. However, in accordance with Manitoba Regulation 59/2002 and Section 17 of the Water Resources Administration Act, a RRVDFA Permit for the structure must be obtained from this office and flood protection must be provided for the booster station.

On behalf of Community and Regional Planning Branch Steinbach, I have reviewed any potential areas of concern that should be addressed as part of the environmental evaluation pursuant to *The Environment Act*.

The subject lands are located in the RM of Franklin encompassing the northern and central portions of the Municipality as well as the southernmost portion of the RM of De Salaberry. The intent of the proposal is to expand PVWC distribution system that involves the installation of approximately 75km of pipeline, construction of a booster station near St. Jean Baptiste and 51 service connections. This expansion is proposed to address a need for treated water for residences and towns in the PVWC Area.

The proposed pipes will be built on municipally owned road right of ways throughout the proposed service area. The area in question within the RM of Franklin are primarily designated "Rural Policy Area 1, Rural Policy Area 2 and Rural Settlement Centre" in the RM of Franklin Development Plan. Policy 10.1 in the public service and utilities section of the RM of Franklin Development Plan states that, the municipality should "provide necessary public utilities and services in accordance with needs of existing and future development conforming to the Municipality's priorities and subject to economic, safety and environmental considerations".

The area in question within the RM of De Salaberry is designated Agriculture 2 in the RM of De Salaberry *Development Plan*. Policy 10.1 in the public service and utilities section of the RM of De Salaberry, *Development Plan* states that, the municipality should "provide necessary public utilities and services in accordance with needs of existing and future development conforming to the Municipality's priorities and subject to economic, safety and environmental considerations".

The subject lands are Zoned "Rural 1, Rural 2, Rural Residential, Limited Rural, and General Development" in the RM of Franklin. Utility infrastructure is a permitted use in all zones and the minimum site requirements are determined by Council.

The subject lands are Zoned "Agriculture 2" in the RM of De Salaberry. Public utilities are a conditional use in the "Agriculture 2" zone and minimum site requirements are determined by Council.

The proposed increase in municipal water service is in keeping with the intent and policies identified in the RM of Franklin and the RM of De Salaberry Development Plan and Zoning By-law. Our office has

no concerns with respect to the proposal.
