## **OVERVIEW:**

Manitoba Conservation and Water Stewardship received a Proposal on March 14, 2014 for the continued operation of a screen printing facility at 21105 Mondor Road, SE 15-9-4 EPM in Ile Des Chenes, Manitoba. The facility manufactures screens and digitally printed signs, decals, banners, T-shirts, hats etc distributed all over North America.

The Department, on November 13, 2014, placed copies of the Proposal in the Public Registries located at Legislative Library (200 Vaughan Street), the Winnipeg Millennium Public Library in Winnipeg and online at

http://www.gov.mb.ca/conservation/eal/registries/5691hdgraphics/index.html. Copies of the Proposal were also provided to the Technical Advisory Committee (TAC) members. A notice of the Environment Act proposal was also placed in the Winnipeg Free Press on November 15, 2014. The newspaper and TAC notifications invited responses until December 16, 2014.

## Manitoba Conservation and Water Stewardship - Compliance and Enforcement Branch

Environmental Compliance and Enforcement Branch has reviewed the above noted Environment Act Proposal dated March 12, 2014 and has the following comments to provide:

The sewage ejector system is receiving wastewater generated from the house, a washroom in the shop, and process water from the shop. A sewage ejector is, as defined in the Onsite Wastewater Management Systems Regulation (M.R. 83/2003), to be used **exclusively** for the disposal of:

- Human fecal or urinary waste and other human body and toilet waste ("sewage"); and/or
- Liquid waste from a dwelling or other building produced by bathing, laundering, or food preparation activities ("greywater")

Additionally, as per Schedule E of M.R. 83/2003, a sewage ejector shall not be connected to more than one single-family dwelling and shall be located in such a location that will ensure that wastewater effluent discharged from it does not pond.

*Use of the sewage ejector to dispose of process water is a contravention of M.R. 83/2003.* 

Most of the chemicals identified in this proposal are biodegradable with the exception of the textile and graphic inks. The Certificate of Analysis (L1429878) provided for the effluent does not contain all components included in the Materials Safety Data Sheets (MSDS). The MSDS of the inks indicate that some of these chemical products should not be released into the environment.

Environmental Compliance and Enforcement Branch requests that the proponent propose an alternative method to dispose of the process wastewater that will avoid the release of potentially hazardous products to the environment.

#### **Proponent Response (January 15, 2015)**

As per our phone conversation on the phone, here is the info you have requested on the ECE form:

All of the waste water from HD Graphics Printed processes, including all chemicals, and inks is now being filtered through the close looped filtration system that we provided information on in our proposal. It is not connected to the Ejector system. The specs and information on that system were provided in our proposal, it was built by "The Water Doctor" company.

There are a series of carbon filters that are attached to the system that "The Water Doctor" company will be taking care of cleaning and having the waste disposed of by millar environmental, allowing HD to continue operations with no waste discharging through our ejector system.

The items outlined in the ECE that are acceptable to be disposed of through the Ejector system is now all that is being disposed of.

#### Environmental Compliance and Enforcement Branch Comments (February 3, 2015)

Most of our concerns are addressed. There are still issues with more than a single family dwelling connected to sewage ejector system, however, as process wastewater is no longer routed to the system, we can follow that up separately from the EAL.

# **Disposition**

The proponent addressed the concern raised. Environmental Compliance and Enforcement Brach has reviewed the response has no further comment. In addition Clause 27 of the draft Environment Act Licence prohibits the discharge of process wastewater through an ejector system.

- Based on the provided annual use of chemicals, it is expected that there will be no significant impact on air quality due to VOC emissions from this facility.
- The odour clause is suggested to be included in the License.

Clause 9 of the draft Environment Act Licence addresses odour nuisance.

Enforcement of the Licence should be assigned to the Environmental Compliance and Enforcement Branch of Manitoba Conservation and Water Stewardship.
