Hydrologic Forecasting has reviewed the subject Environmental Act Proposal (EAP) and has the following comment:

The proposed marina is located adjacent to Lake Manitoba. Aerial photographs (attached) captured during the 2011 flood event indicate that the location was completely inundated during that

The natural ground elevation of the proposed is approximately 248.1 m (814 ft) G. S. of Datum and is therefore subject to the high water of Lake Manitoba. The corresponding Flood Protection Level at this location is approximately 249.6 meters (818.8 feet) G. S. of C. Datum.

Hydrologic Forecasting has no objections to the EAP for the purposes indicated. However, current and future owners should be made aware of the potential flood hazard, and provide flood protection for all permanent structures associated with the marina. Any permanent structures should be constructed to a minimum elevation of the Flood Protection Level of 249.6 meters (818.8 feet) G. S.

Community and Regional Planning has reviewed the SOM Beach Ltd. proposal for a marina to be constructed in 2014 at NW ¼ 6-26-8 WPM approximately 10 miles NW of Ashern in the RM of Siglunes. The proposed marina is to be used primarily by lot owners of an adjacent proposed 21 lot cottage subdivision at Moosehorn Bay on Lake Manitoba.


The affected property is designated *Agriculture Rural* in the Western Interlake Planning District Development Plan By-law No. 2/04 and zoned "AG" Agricultural General in the RM of Siglunes Zoning By-law No.6/05. Amendment to the Development Plan would be required for both the marina and the proposed subdivision.

WIPD By-law 1-13 proposed to re-designate the subject property from Agricultural Rural Area to Recreation Area to accommodate seasonal residential development along the shore of Lake Manitoba. However, the Hydrological Forecasting Branch of Manitoba Infrastructure and Transportation advises that the land involved in the proposed redesignation were entirely inundated by floodwaters during the high water events that occurred around Lake Manitoba in

Accordingly, the Minister of Municipal Government "is not prepared to consider the by-law until a geotechnical analysis is completed by a qualified professional that confirms that the subject lands, and any resulting development can be safely protected from future high water events and that any long-term impacts of wave action and erosion can be suitably mitigated." Consequently, our office cannot support the EAP proposal for a marina at this site at this time.
