Enclosed please find an Environmental Act Proposal (EAP) for the licensing of Russell Redi-Mix Concrete's second asphalt plant. I have also enclosed the necessary application fee for a Class 1 Development for the licensing of an asphalt plant in the Province of Manitoba.

Russell Redi-Mix Concrete (RRMC) has numerous asphalt projects currently scheduled for the 2014 construction season and in turn is proceeding with the proper approvals needed for the operation of an asphalt plant. Currently RRMC has one asphalt plant operating in Manitoba but due unforeseen weather delays RRMC will need to bring in a second plant to try and meet the deadlines put forth by Manitoba Infrastructure and Transportation (MIT).

This second plant will not only create more jobs for Manitobans but also supply the province of Manitoba with the asphalt it needs. RRMC has already been awarded over 300,000 tonnes of bituminous pavement through MIT for the 2014 construction year and has hired a compliment of highly skilled asphalt paving staff.

RRMC looks forward to working with Manitoba Conservation and Water Stewardship and all aspects of government to become an industry leader in the production of asphalt pavement.
