Appendix B - Table 3: Setbacks and Buffers - Active Migratory Bird Nest - 50m setback distance:

If any bird species listed provincially under the Endangered Species and Ecosystems Act or federally under the Species At Risk Act are observed in the project area, this setback distance should increased to at least the minimum distance recommended by Manitoba's Conservation Data Centre for that species. The Wildlife Branch can provide these distances and definitions of disturbance to the proponent if needed. Furthermore, all occurrences of listed species observed during construction and monitoring activities should be reported to the CDC.

Dear Mr. Quimet:

I am writing as a private citizen:

a) To object to the approval of the current Harrow Station to Bishop Grandin Blvd. 115 kV Transmission Project Environmental Assessment Report, dated April 2015, and to object to the request for approval of the Class 2 Development Environment Act Proposal (EAP) submitted by Manitoba Hydro.

b) To request that the "Environmental Assessment Report" dated April 2015 be rejected as incomplete and/or inadequate as an Environment Act Proposal (EAP) and Environmental Impact Statement (EIS), for the specific reasons enumerated below.

c) To request, pursuant to section 11(9)(c) of the Act, that the Director require Manitoba Hydro to prepare and submit to the director an assessment report to include "alternatives to the proposed development processes and locations," and the "details of proposed environmental management practices to deal with the issues;"

d) To request, pursuant to Manitoba Regulation 163/88, that the Director require Manitoba Hydro to provide a description of all previous studies and activities relating to feasibility, exploration, or project siting and prior authorization received from other government agencies, plus a description of the potential impacts of the development on the environment.

e) To require that Manitoba Hydro conduct a proper field survey of the flora and fauna of the affected Project Study Area now, at a time of the year when at least some of them are present. KGS Group did its site visit in September 2014, when most species would have vacated the site.

f) To request that no Harrow-Bishop Grandin Proposal be approved and licenced pursuant to *The Environment Act*, without first referring the completed EAP to the Clean Environment Commission for a public hearing and recommendation.

The Environmental Assessment Review and Report is Incomplete and Inadequate

I request that the "Environmental Assessment Review and Report" dated April 2015 be rejected as incomplete and/or inadequate as an Environmental Impact Statement (EIS), for the specific reasons enumerated below, discussed in relation to the specific mandatory requirements set out in Section 1(1) of the *Licensing Procedures Regulation*, Man. Reg 163/88, and highlighted in italics below:

Manitoba Hydro has not provided:

(i) a description of all previous studies and activities relating to feasibility, exploration, or project siting and prior authorization received from other government agencies;

Manitoba Hydro has really provided only a checklist of items to be examined, and standard corporate practices which may be applied to this project. It should be required to provide specifics for this particular project, including:

(j) a description of the potential impacts of the development on the environment, including, but not necessarily limited to the following:

(i) type, quantity and concentration of pollutants to be released into the air, water

a) or land,

(ii) impact on wildlife,

(iii) impact on fisheries,

(iv) impact on surface water and groundwater,

(v) forestry related impacts,

The EAP states that the site visit was conducted in September, 2014; therefore, the majority of migratory wildlife species would have already left the area; the wet meadow and/or wetland areas were dry; and plants that grow and flower in the spring or early summer were not present or were in senescence. In addition, tall grass prairie is considered an endangered ecosystem. And wetlands are ecologically sensitive areas.

The EAP <u>misleads</u> the reader with respect to the nature of the ecosystem in the Parker Lands area when it states in section 3.18 only that:

"Mr. Chris Friesen (13), Biodiversity Information Manager, MCDC, completed a search of the MCDC rare species database and found no occurrences of federally or provincially listed species (The Endangered Species Act (Manitoba) and Species at Risk Act (Canada)) in the area (Appendix D)."

However, In Appendix D, Mr. Friesen's memo states clearly that:

"The information provided in this letter is based on existing data known to the Manitoba Conservation Data Centre at the time of the request. These data are dependent on the research and observations of CDC staff and others who have shared their data, and reflect our current state of knowledge. An absence of data in any particular geographic area does not necessarily mean that species or ecological communities of concern are not present; in many areas, comprehensive surveys have never been completed. Therefore, this information should be regarded neither as a final statement on the occurrence of any species of concern, nor as a substitute for on-site surveys for species as part of environmental assessments."

(k) a description of the proposed environmental management practices to be employed to prevent or mitigate adverse implications from the impacts identified in clause (j) having regard to, where applicable: containment, handling, monitoring, storage, treatment and final disposal of pollutants; conservation and protection of natural or heritage resources; environmental restoration and rehabilitation of the site upon protection of environmental health; and

Need for Coordination with File 5709.00 – City of Winnipeg Southwest Rapid Transit Corridor Stage 2 Project.

The Manitoba Hydro Transmission Project is being presented in part to facilitate the construction of the proposed Stage 2 of the Southwest Transitway between the Pembina Highway/Jubilee Underpass and the University of Manitoba.

It is proposed that both projects traverse the Parker wetlands, as shown in the attached documents:

- a) Notice of Environment Act Proposal Manitoba Hydro File 5766.00
- b) Harrow to Bishop Grandin Transmission Project Map October 19, 2011
- c) April 20, 2015 letter requiring the City of Winnipeg to provide a detailed report for the approval of the EAB Director prior to construction of the Development (Transitway), on the potential effects of the project on the wetland.
- d) Environment Act Licence No. 3121 dated December 18, 2014, for the Southwest Transitway, conditional upon the conduct of a pre-construction survey in late spring within the Parker lands for Species at Risk, and approval of recommendations by the Director prior to construction.
- e) Cockburn and Calrossie Combined Sewer Relief Works Map January 2015
- f) Southwest Transitway Stage 2 P3 Canada Submission Figure 4 Dillon
- g) City of Winnipeg Misc. Plan No 12251/13 January 16, 2015 (showing Hydro lines crossing the proposed Parker Retention Pond).

Surely these projects should be considered together, and supported by far more factual and relevant evidence than has been presented so far.
