## SUBJECT: Environment Act Proposal (Client File No. 5819.00) RW Packaging – Pharmaceutical Company No. 200, Omand's Creek Blvd, Winnipeg

Winnipeg Regional Office of Environmental Compliance and Enforcement Branch has reviewed the Environment Act Proposal (EAP) report for the above noted facility. The observations and comments are as follows:

- 1. The floor plan for the manufacturing facility was not provided in the EAP to understand the lay out the facility and to identify environmentally significant locations.
- 2. EAP states that facility blends and packages liquids and powders. Details of powders used in the processes and their storage details including the precautionary measures were not described in the report.
- 3. The EAP does not provide a detail description of dedicated internal formulations tanks including purposes, their type and capacity, storage time etc to assess whether these tanks falls into the purview of *Storage and Handling of Petroleum Products and Allied products Regulation* (M.R.188/2001) and *CCME Environmental Code of Practice for aboveground and Underground Storage Tanks Systems Containing Petroleum Products and Allied Petroleum Products* (2003).
- 4. It was noted that Appendix C of EAP, Hazardous Spill Management document:WSH-015 does not include the 24/7 Environmental Emergency reporting contact details. Emergency response protocols pertaining to spills and accidents must be discussed in the report to understand the adequacies.
