Manitoba Infrastructure (MI) has reviewed the proposal under the *Environment Act* noted above and has the following concerns/comments associated with the proposed development:

MI is concerned with the potential change in flow rates (i.e. post development flow will be higher than pre-development flow) into the adjacent ditches because of proposed development/construction of concrete pads and internal road work. A hydraulic study prepared by a Professional Engineer should be provided to MI for review and approval.

MI would also like to remind the applicant that any works falling within the Department's 125ft (38.1m) Controlled Area requires that an application be submitted to the Highway Traffic Board for review and approval.
