

**Instructions for 2011  
Non-Resident Application  
For Angling, Game Bird and Big Game Licences**

---

**PRE-PURCHASE IS AN OPTION**

It is not necessary to pre-purchase your licence before you arrive in Manitoba. You may purchase your licence in person at most Conservation / Water Stewardship offices, including the main office at 200 Saulteaux Crescent in Winnipeg, or at one of the many private vendors located throughout Manitoba. Locations of vendors are available by phoning 1-800-214-6497. Or, as a non-resident hunter or angler, you can purchase your licence by submitting the following application to us at *least 4 weeks* before your expected arrival in Manitoba.

**HOW DO I PRE-PURCHASE**

After printing and completing your application, please **mail** it and your payment to: Cashier, Manitoba Conservation / Water Stewardship, #42, 200 Saulteaux Crescent, Winnipeg, Manitoba, Canada, R3J 3W3.

**ALLOW 4 WEEKS FOR PROCESSING**

*We receive our supply of angling licences in April and **hunting licences at the end of July**, and process all requests in order of receipt. Due to the high volume of applications, we request that you **either mail or fax** each application to us only once. We are unable to confirm receipt of your application (please do not phone). Please allow 4 weeks for your application to be processed and for the licences to be mailed to you.*

If you cannot forward the application prior to 4 weeks before your departure, then we recommend that you purchase your licences after you arrive in Manitoba.

**MIGRATORY PERMIT AND STAMP**

Manitoba Conservation completes and submits to the Government of Canada, a section of the Migratory Game Bird Permit and Stamp that includes some of the hunter's personal information provided on the application as well as the information requested on Page 2 of the application. *If all of the information requested on Page 2 is not completed, we will be unable to provide you with a Migratory Game Bird Permit and Stamp.*

For angling licences, a **RESIDENT OF CANADA** is a person who does not live in Manitoba but has lived elsewhere in Canada for the immediate past six months. Any person who has not lived in Canada for the immediate past six months is a **NON-RESIDENT OF CANADA**.

A conservation licence entitles the holder to the same rights as a regular licence, except for a reduced daily catch limit for some species.

For hunting licences, a **RESIDENT OF MANITOBA** is a Canadian citizen who has his/her home and is ordinarily present in the province of Manitoba immediately preceding the time that he/she purchases a licence **OR** a person who is not a Canadian citizen but has his/her home and is ordinarily present in the province for a period of 6 months immediately preceding the time that he/she purchases a licence. A **NON-RESIDENT (CANADIAN)** is a person who is a Canadian citizen but is not a Manitoba resident. A **FOREIGN RESIDENT** is a person who is neither a Canadian citizen nor a resident of Manitoba.

**BLACK BEAR, CARIBOU, DEER AND MOOSE LICENCES** Non-resident (Non-Canadian) are only available from registered lodge operators or outfitters. Please contact Travel Manitoba, 7th floor, 155 Carlton Street, Winnipeg, Manitoba R3C 3H8 (Phone: 1-800-665-0040) for further details.
