

n May 10, the Manitoba government presented **U**Budget 2000: a balanced financial action plan to guide provincial programs in the year ahead. The plan addresses our needs and priorities today, while building greater opportunities for the future.

NEW HOPE FOR YOUNG PEOPLE

With major emphasis on education and training, **Budget 2000 helps build promising futures.**


- Public schools will receive \$30 million more.
- A 10% reduction to college and university tuition fees will save Manitoba students \$8 million.
- Community college enrollment is set to double over four years, beginning with \$5.1 million more for college expansion alone.
- Scholarships and bursaries will increase by \$16.9 million.
- Universities and colleges will gain \$10.8 million more in operating grants.
- Internet-based training and expanded apprenticeship programs will provide better access to opportunities.

Stronger support for our children's classrooms, with \$30 million more in 2000.




REPAIRING HEALTH CARE

Health care is the number one priority of Manitobans. With better planning and 6% more in the health care budget, we can take action now to reduce waiting lists, improve vital services, and hire more staff.

- More nurses can be hired and trained with the help of a \$3 million fund and the reintroduction of a two-year nursing program.
- Hospitals will be able to open more beds, new units for cancer patients and pediatric extended care.
- More personal care home spaces will be opened.
- Expanded Pharmacare means more Manitobans can count on the drug coverage they need.
- We'll expand home care services like community intravenous therapy, palliative care, and adult day care.
 - \$5 million more will help improve ambulance services across the province and northern patient transport.

Hundreds of nurses will be trained and hired over the next few years.











BALANCING THE BOOKS

Budget 2000 is a commitment to responsible management of government finances. This budget is balanced, despite the financial challenges inherited by the new government.

- Budget 2000 introduces the first long-term plan for comprehensive debt retirement, including unfunded pension liabilities.
- Less than half as much as last year will be drawn from the government's Fiscal Stabilization Fund.
- The bottom line: Budget 2000 has a positive balance of \$10 million.

BALANCING YOUR PRIORITIES

Budget 2000 directs more funding to the services we need most to build a better quality of life for all Manitobans.

- Health care funding is strengthened by 6%.
- Education and training funding is up 4.5%.
- Manitoba parents will gain better access to licensed child care through a \$8.6 million increase.
- Family farms will get more support with stronger crop insurance and other assistance.
- Aboriginal Manitobans will have more opportunities with initiatives like the \$1 million Aboriginal Economic and Resource Development Fund.
- Community safety and renewal will be stepped up with the new Neighbourhoods Alive! program and a 5.3% increase to the justice department.

RESPONSIBLE TAX RELIEF FOR MANITOBA FAMILIES

Budget 2000 means tax savings for Manitoba households, particularly middle and low income families. Manitoba remains one of the most affordable places in Canada to raise children.

- Property taxes are lowered through a \$75 increase to the Property Tax Credit for all Manitoba households, including renters.
- Income tax reductions will benefit all income groups, particularly families and persons living with disabilities.

- The new, simplified income tax structure for 2001 eliminates the use of a Net Income Tax and Surtax.
- The Basic Personal Tax Credit is up from \$578 to \$802.
- The Child Tax Reduction is up from \$250 per child to \$300.
- 15,000 more low income Manitobans will pay no Provincial Income Tax at all.
- The tax credit for charitable donations increases.
- The small business tax rate will be reduced from 7% to 5% by 2002.

These new personal income tax reductions will exceed \$100 million annually by 2002.
