# Manitoba's Economy A Steady Plan for Challenging Times

Manitoba's balanced approach to tax relief and strategic investments in important services puts the province in a position to face the challenges ahead while building for our future. With a diversified economy, a large and stable service sector and growing personal incomes, Manitoba is on track to post economic growth in 2009 that outperforms the national average for a fourth consecutive year.

Even with our stable economy, Manitoba is not immune to today's economic uncertainty. That is why Budget 2009 is a steady, balanced financial plan to create and maintain jobs and critical services, and use the advantages of our economic strengths to sustain our quality of life.

#### **Manitoba's Future**

Budget 2009 builds for the future by investing \$1.6 billion in infrastructure projects that will create jobs for Manitobans and help to stimulate our economy.

- More than \$160 million in social and affordable housing.
- Investments to upgrade and build roads and highways increase to a total of \$535 million
- A new all-purpose road will be developed in partnership with local communities on the east side of Lake Winnipeg.
- \$46 million in municipal and wastewater projects.
- Health capital construction projects including:
  - the Westman Regional Laboratory in Brandon;
  - the cardiac science facility at St. Boniface Hospital;
  - redevelopment of the emergency departments at the Portage and District Hospital and the Victoria General Hospital: and
  - a new 80-bed Aboriginal personal care home.



## **Moving Forward with Education and Training**

By investing in our schools, universities and colleges, Budget 2009 provides opportunities for our young people to develop into the skilled professionals our knowledge economy needs to grow and prosper.

- A 6% increase in base operating grants and strategic program investments for universities and colleges.
- A new bursary fund for prospective apprentices has been established and more training seats will be made available for apprentices.
- Public schools receive a 5.25% increase, or \$53 million the largest investment in public school funding in Manitoba history.
- The number of available scholarships for Aboriginal medical students will double.
- The Tuition Fee Income Tax Rebate will continue to encourage young graduates to build their careers here at home.
- Increased skills training for Manitobans affected by the economic downturn.


### **Keeping Health Care a Priority**



Budget 2009 continues the government's decade-long commitment to providing quality, accessible health care to all Manitobans.

- Increased funding to attract and retain more physicians and specialists, especially in rural and northern Manitoba.
- The Artiste a first in Canada will provide high-precision, non-invasive surgery to patients.
- Funding has been increased to hire more emergency room staff and add new ambulances to the provincial fleet.
- The successful Advanced Access program will be expanded to help physician clinics reduce patient wait times.
- Additional funds will be provided for capital investments in addictions and mental health care services.
- Additional investments in hemodialysis treatment are being made in Russell, Gimli and Winnipeg.

### **Promoting a Green Manitoba**

Budget 2009 balances the protection of Manitoba's natural resources with the need to promote sustainable development and make Manitoba a leader in the green economy.

- Funds for more scientific research to support nutrient reductions in Lake Winnipeg.
- Development of a new provincial campground.
- Investments to help restore Manitoba's largest marshes.
- Development of a new wetland protection and restoration program.
- Increased funding for the e-waste initiative.
- Continued investments in wind, geothermal and other alternative energies.
- Interest rates on PowerSmart loans will be reduced to 5%.
- A new PowerSmart Shop program will help small businesses save resources through energy upgrades.

# A Continued Commitment to Families and Communities





This year's budget supports Manitoba's families and communities by balancing their current needs with investments in their long-term well-being.

#### **Families**

- Entrance fees at provincial parks will be eliminated for the next two years.
- Funds for additional child care spaces and increased wages.
- Increased supports for children in care.
- Neighbourhoods Alive! will expand across the province.
- Easier access to the Primary Caregiver Tax Credit.


#### **Communities**

- Manitoba municipalities will receive \$84 million \$4 million more than last year for roads, transit, public safety and other municipal infrastructure and service priorities.
- Grants for rural economic development initiatives will increase by 8.7%.
- Funding for the City of Winnipeg will increase by \$10.5 million to \$213 million to support transit, road maintenance and repair, and public safety.
- The City of Winnipeg will receive \$4 million in new funding for ambulance services.

#### A Steady Commitment to Tax Relief

Manitoba's long-term commitment to reducing taxes for families and businesses will continue. All 2009 tax commitments made in previous budgets will be maintained.

- The basic Education Property Tax Credit will increase to \$650 saving homeowners and renters an additional \$16 million.
- The basic personal amount, spousal amount and eligible dependent amount will increase by \$100.
- The small business income tax rate will be reduced to zero effective December 1, 2010.
- The general Corporation Income Tax rate will be reduced to 12% on July 1, 2009.
- The Manitoba Mineral Exploration Tax Credit will be extended and increased for three more years and the Mining Tax rate will be reduced.
- Funds for the Community Enterprise Investment Tax Credit will double to provide \$17 million more in investment capital for small and medium-sized businesses and the loan credit available for businesses will triple.
