

# FILING PROVINCIAL TAX RETURNS DURING A POSTAL DISRUPTION

With a mail strike possible by July 2, 2016, the June 2016 Retail Sales Tax (RST) and Health and Education Levy (HE) returns were advance-mailed on June 13, 2016.

While the impact of this action on mail delivery service is unknown at this time, please be advised that **the due dates for all provincial tax returns do not change in the event of a strike**, (i.e. June RST returns remain due July 20, 2016, June HE returns are due July 15, 2016 etc.).

To ensure that your RST and HE returns and payments are filed on time, you are encouraged to file and pay your returns online using our TAXcess service at <u>manitoba.ca/TAXcess</u>.

A postal disruption is just one more reason you should make the switch to TAXcess, our online tax service that allows you to file, pay and view your Manitoba business tax accounts online wherever and whenever you want. It's simple, secure and available 24 hours a day, seven days a week.
