You can also pay online through your financial institution bill payments. Please visit <u>manitoba.ca/TAXcess</u> and click on the *Financial Institution Payment Help* for details.

If paying IFTA through **TAXcess** or your financial institution bill payments, please fax (204-948-2087) or e-mail (<u>MBTax@gov.mb.ca</u>) the return and worksheet. Returns that are not received will be considered late filed and penalty and interest will be assessed. Please note that licence and decal fees cannot be paid through **TAXcess**.

complete Section 2, even if you did not travel at all during the quarter.

Faxed or e-mailed returns are accepted if the return is NIL, has a credit balance or you have paid the taxes on **TAXcess** or through your financial institution bill payments. The faxed or e-mailed return is accepted as the original tax return so please do not mail or drop off a duplicate return!
