

Manitoba IFTA Newsletter—3rd Quarter 2017

2018 Renewals

The 2018 licence and decal fee will remain at \$65 per carrier and \$5 per set, respectively.

Renewal forms will be mailed in the first week of November. Please complete the form and return with payment to our office. Please note that licence and decal fees **cannot** be paid through **TAXcess**.

The 2018 IFTA credentials will **not** be renewed if the third quarter has not been filed or there are delinquent tax return(s) and/or tax(es) owing under IFTA and/or other tax statutes administered by the Taxation Division.

Display of 2018 Renewal Credentials

You may operate with the 2018 IFTA decals and licence beginning November 1, 2017. However, please note that you are responsible for filing the fourth quarter 2017 return. Failure to do so may result in suspension of your IFTA credentials.

MB Travel Only

Travelling in Manitoba only? Please check the box "No Travel Outside of MB" in Section 1 and complete Section 2, even if you did not travel at all during the quarter.

To avoid penalties and interest, the 3rd Quarter 2017 tax return must be filed and any amount due must be paid by **Tuesday, October 31st, 2017**.

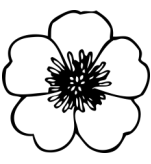
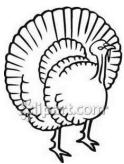

Returns that are not received will be considered late filed and penalty and interest will be assessed. **Please note that licence and decal fees cannot be paid through TAXcess.**
