### 2017 Renewals

If you have not received your 2017 licence and decals, please contact the Taxation Division at 204-945-5603 or Manitoba Toll Free at 1-800-782-0318.

Please note that IFTA credentials will **not** be renewed if there are delinquent tax return(s) and/or tax(es) owing under IFTA and/or other tax statutes administered by the Taxation Division.

**If you do not renew for 2017 by February 28th, 2017 your IFTA account will automatically be closed.**

### IFTA Decals

Manitoba Taxation and the IFTA Law Enforcement Committee require that valid IFTA decals are affixed on the exterior portion of both sides of the cab. The proper placement of IFTA decals will help you avoid costly delays on the road. Do not place IFTA decals on windows, mirrors, tanks, or vents. Please see Information Notice, *IFTA Decal Placement Guide*, for proper placement of IFTA decals on vehicles.

Additionally, please remove all expired or non-valid decals from your vehicle.

#### MB Travel Only

Travelling in Manitoba only? Please check the box “No Travel Outside of MB” in Section 1 **and** complete Section 2, even if you did not travel at all during the quarter.
