The Prearranged Funeral Services Act

After six months of consultations, the Board is now developing changes to the regulation.

Upon proclamation, administration of *The Prearranged Funeral Services Act* will be transferred from the Public Utilities Board to the Funeral Board of Manitoba. This is part of a larger plan to transfer all relevant funeral services acts and legislation to the Funeral Board to provide the profession and the public with one convenient organization to address their needs. The Funeral Board of Manitoba will be establishing an Education Committee who will be reviewing the list of accredited courses. Once approved by the Board, a list of the courses will be posted on the website and will be updated regularly.

2013 Licenses

All applications for license renewals will be mailed out by mid-October 2012. The forms have been improved to reflect changes that have occurred since last year's renewal.

In partnership with Vital Statistics Agency, we ask you to please remember to take the *Registration of Death* form when a deceased person is released to you from a hospital or health care facility. Once you've completed the form, return it to Vital Statistics Agency without delay. Additionally, we suggest you keep a copy of this form or the information contained in it on file as a safeguard.

Funeral Director Certificate Program

The Funeral Board, Red River College, and other stakeholders have worked very hard to develop a new funeral education program. A well-attended Information Session occurred on September 11, 2012. The full program will be available to new applicants in January 2013, although two courses are available this month. Red River College has indicated that they've received interest in the program from over 60 people to date. The Board has also received numerous phone calls regarding the new program.

Compliance Program

On behalf of our inspector, John Delaney, we would like to thank all Funeral Homes and Funeral Directors/Embalmers for their continued cooperation during this year's inaugural compliance audit process.
