Subject: MHSAL Transformation Program – Call for Expressions of Interest (EOI)

The Health System Transformation Program has been established to coordinate and manage the integration of all health transformation initiatives in the province. Over the coming months, talented employees will be required to work directly on the transformation initiatives. The Transformation Leadership Team's (TLT) goal is to have internal health system staff support the Transformation Program, outside of their regular responsibilities, without negatively affecting service delivery.

This is a call for expressions of interest (EOI) for staff, managers, directors and executives to become a member of the Transformation Program's Transformation Management Office (TMO). The TMO is responsible for developing and executing the integrated Transformation Program plan.

The transformation roadmap and the associated resource requirements are not yet finalized. However, it is anticipated that the Transformation Program will be recruiting for the following types of roles / skills:

• Employed with Northern Regional Health Authority, Interlake-Eastern Regional Health Authority, Southern Health-Santé Sud, Prairie Mountain Health, Winnipeg Regional Health Authority, Manitoba Health Seniors and Active Living, CancerCare Manitoba, Diagnostic Services Manitoba (which becomes Shared Health on April 3, 2018), the Addictions Foundation of Manitoba and these organizations' non-devolved facilities

This is an Expression of Interest only. You do not need to seek your manager's approval to submit the EOI and all EOIs are confidential. You will not receive an immediate response. The Transformation Program will review expressions of interest and will match potential candidates with required roles. The Transformation Program will contact you to determine if you may be interested in a role with the TMO, after which there will be discussion with your organizational leaders. You do not have to commit in order to express your interest and the Transformation Program is not required to review your EOI.

EOIs will be accepted after April 27, 2018 but this date will be used as target for the first review by the TMO. Subsequent requests may be issued throughout the course of the Transformation Program.
