Duties:

Under the direction of the Manager of Estimates and Inspections, Inspectors work independently and as part of a team to ensure the effective and timely delivery of inspections for the Manitoba Housing portfolio. Inspections are carried out on direct and sponsored managed properties as well as privately owned homes that qualify for housing-related programs. Main duties include performing inspections in accordance with guidelines and standards, providing written scopes of work and recommendations that are supported by preliminary estimates. Areas of focus include but are not limited to: building structure, building envelope, mechanical, electrical, interior finishes, fire/life safety and building function (review of building's ability to accommodate its intended use). Inspections carried out on direct-managed Manitoba Housing properties assist Manitoba Housing in developing capital plan fiscal requirements.
