Note 1 : If you qualified as a Northern Resident, you will continue to be considered a Northern Resident if you were absent from the preference zone during the last six (6) months but:

- a) you were absent for less than six (6) weeks accumulatively , or
- b) you were receiving medical treatment, or
- c) you were attending a recognized educational institution or
- d) you were employed on the Project as an Apprentice, laid off , and was absent from the region for training/employment related to that apprenticeship not exceeding 180 days measured from lay off, and are a member in good standing of the applicable local union.

Note 2: If you qualified as a Northern Resident and are Aboriginal and have successfully completed **Pre-Project Training**, and **have not left the preference zone exceeding 90 calendar days** to gain employment experience, you will continue to be considered a Northern Aboriginal. (You will continue to have Northern Aboriginal preference for re-employment as an apprentice in that trade only).
