15 13(4.1) of the act for all four complaints, that is 2010/64,  
16 2010/82, 2011/203 and 2011/93.

18 previously been made at I assume the time of the first  
19 appearance likely.

20 MR. MCKENNA: That's correct.

21 THE JUDGE: All right. Do you have any submission  
22 with respect to that, Your Honour?

23 MR. [REDACTED]: Yes, Your Honour. No. I have no  
24 objection.

25 THE JUDGE: No. Okay.

26 THE CLERK: Sorry. What's the section number?


27 THE JUDGE: It's Section 13(4.1). There will be a
