Basic fee for inspection of an installation of an unfired pressure vessel, excluding a propane or anhydrous ammonia tank, exceeding 36 inches in diameter is	24 (8)	\$ 60.00
Biennial inspection fee for an unfired pressure vessel, excluding a propane or anhydrous ammonia tank, varies with the size of the pressure vessel, as follows:	24 (9)	
Not exceeding 24 inches in diameter	24 (9) (a)	\$ 90.00
Exceeding 24 inches in diameter but not exceeding 36 inches in diameter	24 (9) (b)	\$ 100.00
Exceeding 36 inches in diameter	24 (9) (c)	\$ 180.00

FEE FOR STAMPING BOILER OR PRESSURE VESSEL		
Fee for stamping a boiler or pressure vessel is	27 (a)	\$ 60.00

FEE FOR SPECIAL OR ADDITIONAL INSPECTION		
Where a special inspection is requested or an additional inspection is required by reason of material or work previously found by an inspector to be unsatisfactory, the fee for the special or additional inspection is the inspection fee under this regulation plus the fee per hour and travelling expenses	28	\$ 115.00

FEE FOR WEEKEND OR HOLIDAY INSPECTION		
Where an inspection is requested to be made on a Saturday, Sunday or general holiday, the fee for each inspection plus travelling expenses is	29	\$ 900.00

PROPANE AND ANHYDROUS AMMONIA TANKS		
The biennial inspection fee for a propane or anhydrous ammonia tank that has a capacity of 1,000 gallons or less is	24 (10)	\$ 125.00

PROPANE AND ANHYDROUS AMMONIA TANKS LARGER TANKS		
The biennial inspection for a propane or anhydrous ammonia tank that has a capacity of more than 1,000 gallons is \$ 125 for the first 1,000 gallons and for each additional 1,000 gallons of capacity or portion thereof e.g, (500 gal) = \$ 10.00	24 (11)	\$ 10.00

FEE FOR DUPLICATE CERTIFICATE		
Where a certificate of inspection has been lost, destroyed or defaced, a duplicate may be issued on payment of a fee	30 (1)	\$ 40.00

AUDIT OF QUALITY ASSURANCE PROGRAM		
Where a quality assurance program or quality control program is required by a code or standard referred to in this regulation, the fee for an audit of the program per hour is	23 (5)	\$ 90.00

AMMONIA OR GAS DISTRIBUTION PLANT		
The fee for a plan and site inspection of an anhydrous ammonia or liquified petroleum gas distribution plant is	24 (14)	\$ 180.00

REFINERIES AND CHEMICAL PLANTS		
The fees payable for the inspection of refineries and chemical plants on continuous nondestructive testing programs inspected by audit vary with the size of the plant, as follows:	24 (16)

NUCLEAR COMPONENT		
The fee for an in-service or non-shop inspection of a nuclear component per hour is	24 (18)	\$ 170.00
GUARDED PLANT		
The fees for the inspection of a plant that is defined or classified as a guarded plant under The Power Engineers Act or the regulations under that Act are as follows:	24 (19)
