



**Canadian women & the struggle for equality** / Lorna R. Marsden. 1st ed. Don Mills, Ont. : Oxford University Press, c2012. xi, 290 p.

#### From Oxford University Press:

Establishing equality as a fact of daily life has been a protracted struggle, and one that remains far from finished. Over the last century and a half since Confederation, this struggle has taken on a unique character in Canada [...] Lorna R. Marsden, sociologist and activist-who has herself been involved in the action-chronicles the circumstances, the people, and the social changes that have characterized women's journey down the long road toward equality. Her account considers changes brought about by such forces as war, immigration,


and public health, as well as other complex historical changes, such as legal evolution and employment opportunities.

#### From University of Toronto Press:

Coming out of the 2000 Canadian federal election, the dominance of the Liberal Party seemed assured. By 2011 the situation had completely reversed: the Liberals suffered a crushing defeat, failing even to become the official opposition and recording their lowest ever share of the vote. Dominance and Decline provides a comprehensive, comparative account of Canadian election outcomes from 2000 through to 2008. The book explores the meaning of those

outcomes within the context of the larger changes that have marked Canada's party system since 1988. It also shows how these trends were consistent with the outcome of the 2011 federal election. Throughout the book a variety of voting theories are revisited and reassessed in light of this analysis.

### Robert J. Shiller Finance *and the* Good Society

*Finance and the good society* / Robert J. Shiller. Princeton, N.J. : Princeton University Press, c2012. xiii, 288 p.

Shiller [...] believes the recent "financial crisis was...due to fundamental structural shortcomings in our financial institutions." [...] Shiller argues that we must still address the financial system's malfunctions and deeper sources of the problems, which have not been solved by new legislation or regulations, by increasing the public's understanding of the "principles underlying corporations" in order to align corporate interests with society's. It is this "democratization and humanization of finance" that will lead to the good society, one in which citizens

feel that basic economic justice is assured. VERDICT [...] the book convincingly calls for better fiscal education and claims that greater knowledge will lessen resentment and inequality, improve comprehension, and facilitate "the good society." An excellent resource for readers interested in understanding and improving financial capitalism.
