province, and is grateful for our ongoing partnerships with Manitoba organizations such as the Historical Society in continuing to grow our large collection of Manitoba publications.



The multiculturalism question: debating identity in 21st-century Canada / Jack Jedwab. Montreal: McGill-Queen's University Press, 2014. viii, 256 pages. FC 105 .M8 Mul

From Choice Reviews:

This edited volume features an introduction and 12 chapters from a team of specialists who examine the Canadian federal government's multicultural ideology, policy, and program. Contributors reflect on the implications of Canada's policy, which recognizes cultural diversity and aims at integration of different ethnic communities. This book mirrors a vigorous, controversial debate concerning official government policy. According to one school of thought, the multicultural policy has succeeded in creating a framework for an inclusive national identity by ensuring the full participation of all Canadians in all facets of society. Furthermore, this policy not only emphasizes

pluralism, diversity, and tolerance, but also reinforces support for a belief in the economic benefits of immigration. However, critics, including the French in Quebec and the Aboriginal community, argue that multiculturalism promotes hierarchies and relativism, and has not been effective in reducing social inequality. Moreover, they suggest, it is really a settlement policy that encourages assimilation and pays less attention to contemporary injustices and the like. These essays demonstrate the interplay of race, ethnicity, language, religion, gender, and interculturalism.






From the publisher:

Judge John Reilly, now retired, was the youngest judge ever appointed to the Provincial Court of Alberta. For most of his 33 years on the bench he was the circuit judge for the Stoney Indian Reserve at Morley, Alberta.

During his career he became interested in aboriginal justice and saw the failure of the "white" legal system to do justice for aboriginal people, the harm caused to them by Canadian colonialism, and the failure of all levels of government, including tribal government, to alleviate their suffering and deal with the conflicting natures of European-style law and Indigenous tradition and circumstance.

Using empirical data on production, trade, investment, profits, and foreign ownership in Canada, as well as a new analysis of the overlap among the boards of directors of the top 250 firms in Canada and the top 500 firms worldwide, Klassen argues that it is the increasing integration of Canadian


businesses into the global economy that drives Canada's new, increasingly aggressive, foreign policy. 

Since 1960, Canadian industry has lagged behind other advanced capitalist economies in its level of commitment to research and development. *Asleep at the Switch* explains the reasons for this underperformance, despite a series of federal measures to spur technological innovation in Canada. [...] Remarkably, and with few results, federal programs and measures continued to emphasize a market-oriented approach. Asleep at the Switch details the ongoing attempts by the federal government to increase the



level of innovation in Canadian industry, but shows why these efforts have failed to alter the pattern of technological dependency.

From the publisher:

The introduction of medicare in Saskatchewan marks a dividing point in the history of the province and Canada. Before 1962, access to medical care was predicated on ability to pay and private health insurance. After 1962, access to needed medical care became a right in Saskatchewan, later extended to the rest of Canada. The battle to establish medicare was hard fought and in the front lines were community clinics, non-profit, consumer-controlled health co-operatives offering interdisciplinary primary care. Stan Rands was one of the key individuals who established and managed community

clinics in Saskatchewan.

Here is his story of how the medicare battle was fought by those who not only wanted to eliminate money as a barrier to care but also wanted to change the way health care was delivered. This is the inside story of a more radical vision of medicare, one that has still not been achieved in Canada.
