Before a provincial election, there is a 90-day blackout period that limits public communications by government.


Due to this restriction, the next *Selected New Titles* will be published after the April 19th, 2016 Manitoba provincial election.

Librarian's Picks



Canada's residential schools : the final report of the Truth and Reconciliation Commission of Canada. Montreal ; Kingston ; London ; Chicago : Published for The Truth and Reconciliation Commission of Canada by McGill-Queen's University Press, 2016. 6 volumes in 7 tomes. Canada TRC

From the publisher:

Between 1867 and 2000, the Canadian government sent over 150,000 Aboriginal children to residential schools across the country. Government officials and missionaries agreed that in order to civilize and Christianize" Aboriginal children, it was necessary to separate them from their parents and their home communities. For children, life in these schools was lonely and alien. Discipline was harsh, and daily life

was highly regimented. Aboriginal languages and cultures were denigrated and suppressed. Education and technical training too often gave way to the drudgery of doing the chores necessary to make the schools self-sustaining. Child neglect was institutionalized, and the lack of supervision created situations where students were prey to sexual and physical abusers. Legal action by the schools' former students led to the creation of the Truth and Reconciliation Commission of Canada in 2008. The product of over six years of research, the Commission's final report outlines the history and legacy of the schools, and charts a pathway towards reconciliation.

The 49th parallel has long held a symbolic importance to Canadian cultural nationalists as a strong, though permeable, border. But in contemporary Canadian culture, the border has multiple meanings, and imbalances of cultural power occur both across the Canada-US border as well as within Canada. Discrepant Parallels examines divergent relationships to, and investments in, the Canada-US border in a variety of media, such as travel writing, fiction, poetry, drama, and television. Tracing cultural production in Canada since the 1980s through the periods of FTA and NAFTA negotiations, and into the current, post-9/11 context, Gillian Roberts grapples with the border's changing




relevance to Canadian nationalist, Indigenous, African Canadian, and Latin American perspectives. Drawing on Kant and Derrida, she theorizes the 49th parallel to account for the imbalance of cultural, political, and economic power between the two countries, as well as the current challenges to dominant definitions of Canadianness. Focusing on a border that is often overshadowed by the contentious US-Mexico divide, Discrepant Parallels analyzes the desire to establish Canadian-American sameness and difference from a multitude of perspectives, as well as its implications for how Canada is represented within and outside its national borders.


There is a dearth of scholarship concerning provincial elections in Canada, and the authors make a significant contribution to this area through their analysis of the 2011 Ontario provincial election in which Dalton McGuinty's Liberals were able to retain power by defeating the Progressive Conservative (PC) Party of Ontario and the New Democratic Party (NDP). The work covers the political and economic setting of the 2011 contest. [...] What readers learn is that the parties did not really try to sway voters—rather, they attempted to mobilize their base. The campaigns did not alter

their messages in response to other campaigns or voter sentiment; much of the media coverage of the campaign focused on the "horserace" rather than the issues, and Ontario's voters often select a provincial government as a counterweight to the federal government. With conservatives in power in Ottawa, the Ontario electorate returned a liberal government to Queen's Park, continuing a longstanding pattern.


Leach, an NHL star in the 1970s, was nicknamed the Riverton Rifle for his skills as a scoring sniper, and his fast-moving autobiography has some of that speed and momentum. [...] There is plenty of detail about his days in the NHL: his beginnings in Boston, suffering with the hapless California Golden Seals, glory days in Philadelphia, and a forgotten final season in Detroit. He also describes the destructive effect that alcoholism had on his career and marriage, and how he rebuilt his life after rehabilitation. Leach includes some funny family stories, including some about his

son, Jamie, who also played in the NHL, but he dishes little dirt about teammates.

This extremely well-documented study provides an overview of immigration in Canada from historical, current, and future perspectives. From the politics of immigration in the past to the possibilities of identity in a post-national world, Fleras (sociology, Univ. of Waterloo, Canada) guides readers with essays, examples, philosophies, charts, and data that are exceptionally useful. He views citizenship and immigration as multidimensional and is sensitive to diversity, racialized issues, gender, refugee status, and the labor market imperative, addressing the many social issues involved. [...] The author also addresses issues for the future, examining



questions of citizenship in a global, international, and multicultural society: people with multiple and multifaceted identities living in a post-national world where ambiguities exist, borders are uncertain, and cosmopolitanism is more the norm than the exception.
