Mr. Murray – Legislative Assembly of Manitoba to strongly urge the Premier to consider calling an independent public inquiry into the Crocus Investment Fund scandal. (K. Bridgeman Magnowski, B. Robin, B. Robin and others)

Mr. LAMOUREUX – Legislative Assembly of Manitoba to request the Legislative Assembly of Manitoba to consider the need to seek clarification on why the Government did not act on fixing the Crocus fund back in 2001 and to urge the Premier and his Government to cooperate in making public what really happened. Mr. MARTINDALE – That the Association of former Manitoba MLAs be incorporated by an Act of the Legislature of Manitoba. (A. Mackling, C. Evans, A. Gray and others)

- 1. Will the Minister of Education, Citizenship and Youth strike a COLA advisory committee to review the COLA issue and to make recommendations to him on reaching a sustainable solution?
- 2. Will the Minister of Education, Citizenship and Youth ensure that thorough and full actuarial modeling is carried out related to the teachers' pension plan and COLA and that this information be provided to the COLA advisory committee to assist them in making their recommendations?
- 3. Can the Minister of Education, Citizenship and Youth tell us if all schools in Manitoba now have a finalized code of conduct in place that addresses bullying?
- 4. Can the Minister of Education, Citizenship and Youth tell us if there is consistency in all of the codes of conduct regarding experiences and consequences of bullying?

- 5. Can the Minister of Education, Citizenship and Youth tell Manitoba why he refused, on three separate occasions, to provide the Opposition with copies of these codes of conduct? Why did he refuse to share this information about how schools are addressing bullying?
- 6. Has the Minister of Education, Citizenship and Youth investigated the excessive violence reported at the R. B. Parker Collegiate in Thompson?
- 7. Is the Minister of Education, Citizenship and Youth giving more than lip services to his Safe Schools legislation?
- 8. Why is the Minister of Education, Citizenship and Youth refusing to fund the Director of Safe Schools Manitoba at a full-time position and why are there no support staff and administrative staff available to Dr. Mary Hall from the Department of Education?
- 9. What is the Minister of Education, Citizenship and Youth doing to address the crisis situation in the Leaf Rapids Education Centre?
- 10. Will the Doer Government commit to eliminating, in Manitoba their aggressive ad campaigns urging people to gamble? Why are they promoting something they so stridently objected to when they were in Opposition?
- 11. Will the Doer Government follow through with their commitment to fully fund the requirements of Bill (No. 13)?
- 12. What is the Minister of Education, Citizenship and Youth doing to address concerns that there is an identified need for enhanced pre-service training and on-going professional development for practicing teachers in the area of student assessment?
- 13. What is the Minister of Education, Citizenship and Youth doing to address concerns that increased resources are needed in the areas of language training and social services for immigrant and refugee students and their families to ease the transition and integration of newcomers to Manitoba's diverse cultural mosaic?
- 14. What is the Minister of Education, Citizenship and Youth doing to improve Manitoba's high school graduation rates?
- 15. When will the Doer Government address the education funding mess in this province and remove education funding from property taxes?
