Hon. Mr. GERRARD moved:

Resolution No. 18: Adopt Jordan's Principle

WHEREAS Jordan River Anderson needlessly and tragically spent his entire life in hospital due to jurisdictional disputes; and

WHEREAS all children in Manitoba should know the comforts of home and their community and should never have to sacrifice these rights; and

WHEREAS Jordan's Principle states that the rights of the child should be considered first in providing health care and social services; and

WHEREAS the absence of timely access to quality health care and social services can lead to sub-optimum child development; and

WHEREAS timely access to quality health and social services is a right, not a privilege, to be afforded to all children in Manitoba; and

WHEREAS Jordan's Principle has been widely supported.

THEREFORE BE IT RESOLVED that the Members of the Legislative Assembly of Manitoba consider supporting Jordan's Principle and its immediate application in order to provide the best possible care and support for the children of Manitoba.

The following petitions were presented and read:

Mr. DYCK – Legislative Assembly of Manitoba to request the Minister of Health to strongly consider giving priority for funding to develop and staff a new 100 bed long-term-care facility so that clients are not exposed to unsafe conditions and so that Boundary Trails Health Centre beds remain available for acute care patients instead of waiting placement clients. (E. Epp, M. Butler, D. Ehnes and others)

Mrs. MITCHELSON – Legislative Assembly of Manitoba to urge the Premier to consider reversing his decision to increase Pharmacare deductibles by 5 percent in Budget 2008 and to consider reducing health care bureaucracy, as previously promised, and to consider directing those savings into sustaining Pharmacare and improving patient care. (T. Kardynal, A. Jaarsma, E. Matthisen and others)

Mrs. DRIEDGER – Legislative Assembly of Manitoba to request the Premier of Manitoba and the Minister of Health to consider providing CancerCare Manitoba with the appropriate funding necessary to provide the standard care treatment – Avastin – to all colon cancer patients and to consider accelerating the process by which new cancer treatment drugs are added to the formulary so that more Manitobans are able to be treated in the most effective manner possible. Mr. BOROTSIK – Legislative Assembly of Manitoba to request the Minister of Education Citizenship and Youth to consider removing education funding by school tax or education levies from all property in Manitoba and to consider finding a more equitable method of funding education such as general revenue following the Constitutional funding of education by the Province of Manitoba. (L. Shirtliffe, L. Shirtliffe, R. Funk and others)

Mr. LAMOUREUX – Legislative Assembly of Manitoba to urge the Provincial Government to consider establishing a 90 day guarantee for processing an application for a minimum of 80% of applicants that have family living in Manitoba and to consider removing the use of the restrictive job list when dealing with the family sponsor stream. (J. De Leon, A. Garcia, R. Peralta and others)

Mr. MAGUIRE – Legislative Assembly of Manitoba to request the Minister of Infrastructure and Transportation to consider making the completion of the paving of the shoulders on the Trans Canada Highway an urgent Provincial Government priorty and to clearly articulate a timeframe for paving the shoulders on the Trans Canada Highway in Manitoba.
