THIS LICENCE IS ISSUED TO:

Rural Municipality of Whitemouth: Applicant

The Applicant shall comply with the following limits, terms and conditions for the construction, operation and maintenance of a domestic water supply located in the Rural Municipality of Whitemouth. The construction of the water intake, mainline, service line, and associated works shall be in accordance with the drawings, details and specifications filed by the Manitoba Water Services Board, dated the 10th of October, 1991. The Whitemouth River crossings shall be constructed at the locations identified on the drawings titled *Pipeline Plans*, *Project No. 466*, sheets 2 of 8, 4 of 8, and 5 of 8, filed on the 13th and 22nd of January, 1992 as additional information to the Environment Act Proposal.

- 1) The Applicant shall tunnel the three pipeline water crossings of the Whitemouth River located on SE 1/4 2-12-11E, SE 1/4 15-12-11E, and NE 1/4 9-13-11E. The tributary stream pipeline crossings known as Bog Creek and Smith Creek shall also be tunneled. The Applicant shall not undertake any alternative methods of stream crossings without the prior approval from the Director.
- 2) The Applicant shall locate the water pipeline along P.R.# 408 from PTH #11 to the Whitemouth River in accordance with the route identified on the drawing titled *Pipeline Plan*, *Project No. 466*, *Sheet 2 of 8*, filed as additional information to the Environment Act Proposal on January 22, 1992.
- 3) The Applicant shall pile topsoil and subsoil from back-hoe, trenching and grading operations separately prior to reuse.
- 4) The Applicant shall replace topsoil in disturbed areas after spring breakup when soil conditions are suitable for handling.
- 5) The Applicant shall re-establish the profile of all water crossings to the preconstruction condition.
- 6) The Applicant shall seed disturbed, non-agricultural areas including riparian zones with a mixture of native and/or introduced grasses.

- 7) The Applicant shall provide a schedule of construction activity and the intended locations of the activity to an Impact Assessment Officer of the Historic Resources Branch one week prior to beginning construction.
- 8) The Applicant shall provide to the Director written evidence that a Licence has been obtained pursuant to The Water Rights Act, from Water Resources Branch, Manitoba Department of Natural Resources.
- 9) The domestic water supply shall be operated in accordance with Manitoba Regulations under the Public Health Act and all operating requirements as recommended Manitoba Environment.
- 10) All waste oil products generated by the machinery used in the construction of the Project shall be collected and disposed of in accordance with Manitoba Environment requirements.
