S1/2 5-3-4 WPM in the Town of Winkler and the Rural Municipality of Stanley, and subject to the following specifications, limits, terms and conditions:

SPECIFICATIONS. LIMITS . TERMS AND CONDITIONS

- 1) The Licencee shall construct the Development in accordance with the Winkler Golf Club Master Plan prepared by David Wagner and Associates, filed with the Environment Act Proposal, dated February 14, 1992.
- 2) The Licencee shall obtain an annual Pesticide Use Permit pursuant to Manitoba Regulation 94/88R for the storage, handling and application of pesticides in conjunction with the Development.
- 3) The Licencee shall not use any mercury based fungicides on the Development.
- 4) The Licencee shall locate a pesticide storage facility in a separate, dry, well ventilated building that will not be subject to flooding and shall be constructed in such a way as to contain runoff from the complete pesticide storage area. The pesticide storage facility shall be enclosed with a security fence.

REVOCATION

If in the opinion of the Director the Licencee has exceeded or is exceeding the specifications, limits terms and conditions set out herein, the Director may revoke, temporarily, or permanently, this Licence.
