AN ORDER OF THE CLEAN ENVIRONMENT COMMISSION

UNDER THE CLEAN ENVIRONMENT ACT

RE: THE CLEAN ENVIRONMENT COMMISSION and AWARD MARBLE LTD., Applicant,

WHEREAS

pursuant to the provisions of The Clean Environment Commission Award Marble Ltd. submitted a proposal to the Department of Mines, Resources and Environmental Management in connection with the operation of a synthetic marble manufacturing plant, with associated dust and gaseous emissions, said plant being located at or near 324 - 2nd Street, N.E. in the Town of Altona, Manitoba;

AND WHEREAS

in the absence of limits being prescribed by a Regulation under the said Act, the said proposal was referred to The Clean Environment Commission for the prescribing of limits;

AND WHEREAS

no representation was made to The Clean Environment Commission by any person who is or who is likely to be affected by an Order of the said Commission prescribing limits in connection with the said operation;

AND WHEREAS

the said Commission considered the said proposal on the 14th day of November, 1977;

IT IS HEREBY ORDERED THAT

- 1. The Applicant shall ensure that solid particulate emissions from any stack or vent of the said operation are not in excess of 0.23 grams per standard cubic meter calculated at 25° Celsius and 760 millimeters of mercury at the point of emission.
- 2. The Applicant shall ensure that at any point of impingement off the premises of the said operation, odours arising from the said operation are not detectable in an area zoned residential when the odorous air is diluted with an equal volume of odour free air.

3. The Applicant shall ensure that a high standard of equipment maintenance and plant housekeeping is carried out at all times consistent with meeting the limits set out in Clauses 1 and 2 of this Order.
