AN ORDER OF THE CLEAN ENVIRONMENT COMMISSION

UNDER THE CLEAN ENVIRONMENT ACT

RE: THE CLEAN ENVIRONMENT COMMISSION and LANDMARK FEED MILL LTD., Applicant,

WHEREAS

pursuant to the provisions of The Clean Environment Act, Landmark Feed Mill Ltd. filed an application with the department of Mines, Natural Resources and Environment in connection with the operation of a feed mill located on the SE4 of Section 22, Township 8, Range 5E, on Main Street North in the unincorporated village of Landmark, Manitoba;

AND WHEREAS

in the absence of limits being prescribed by a Regulation under the said Act, the said application was referred to The Clean Environment Commission for the prescribing of limits;

AND WHEREAS

no representations were made to the Commission by any person who is or who is likely to be affected by an Order of the Commission prescribing limits on the said operation;

AND WHEREAS

the Commission considered the said application on the 19th day of March, 1979;

IT IS HEREBY ORDERED THAT

- 1. The Applicant shall ensure that particulate emissions from the various processes of the said operation are not in excess of 0.57 grams per standard cubic meter calculated at 25° Celsius and 760 millimeters of mercury at the point of emission.
- 2. The Applicant shall ensure that particulate matter from any source of the said operation does not become airborne to such an extent that the particulate matter remains visible past the property line of the said operation.

- 3. The Applicant shall ensure that odours emanating from the said operation are not detectable in a residential area when one volume of odorous air is diluted with one equal volume of odour-free air.
- 4. The Applicant shall ensure that sound emissions from the said operation do not result in sound levels*, as measured beyond the property line of the said operation and within 15 meters of a residence, in excess of:
 - (a) 60 dBA during the daytime hours of 7:00 a.m. to 10:00 p.m. local time; and
 - (b) 50 dBA during the nighttime hours of 10:00 p.m. to 7:00 a.m. local time.
- 5. The Applicant shall ensure that a high standard of equipment maintenance and good housekeeping practices are carried out at all times to meet the requirements of Clauses 1, 2, 3 and 4 of this Order.

* sound level measurements shall be conducted using a sound level measuring device which equals or surpasses the requirements of Canadian Standards Association Standard Z107.1-1973 (or the equivalent) for Type 1 precision sound level meters, operated on the "A-weighting network" and "slow" meter response. The sound level measuring device shall be calibrated and operated according to the manufacturer's instructions.
