#### **OVERVIEW:**

On September 28, 2017, the Department of Sustainable Development received a proposal for a Class 2 licence pursuant to The Environment Act for the De Salaberry East Station Project.

The project involves the construction, operation, and maintenance of a new 230-66 kV station in NE 35-6-4-E, northwest of Kleefeld, Manitoba.

Copies of the Proposal were placed in the Public Registries located at the Legislative Library (200 Vaughan Street), the Winnipeg Millennium Public Library, and the Environmental Approvals Branch Website at

http://www.gov.mb.ca/sd/eal/registries/5917desalaberry/index.html.

A notice soliciting public comments on the Proposal was placed in the Steinbach Carillon on Thursday, October 19, 2017. Copies of the Proposal were provided to the Technical Advisory Committee (TAC) for this project, which is composed of provincial government representatives with expertise on the potential impacts of the project. The newspaper and TAC notifications invited responses until November 20, 2017.

This report provides a summary of the Environmental Approvals Branch's review of the comments received on the Proposal and licence recommendations. A draft Environment Act licence is attached.
