Boil Water Advisories Issued as a Precautionary Measure

1. Private Water Sources - Issued March 25, 2009 Chief Medical Officer of Health As a precautionary measure, the Office of the Chief Medical Officer of Health for Manitoba advises that all people using water from wells or other sources that may have been affected by flooding or spring run-off should boil their water before using it or find alternative supplies of drinking water until flooding subsides and appropriate tests are satisfactory.
