### **Boil Water Advisories Issued as a Precautionary Measure**

Private Water Sources - Issued March 25, 2009 Chief Medical Officer of Health As a precautionary measure, the Office of the Chief Medical Officer of Health for Manitoba advises that all people using water from wells or other sources that may
