## 2014.05.02 UPDATES: BOARD, DEPARTMENT

### .1 Chair's Update

The Chair congratulated Cordella Friesen on behalf of the Board on her new role as the Executive Director of Apprenticeship Manitoba.

#### .2 Executive Director's Update

Cordella Friesen updated the Board on organizational changes within Apprenticeship Manitoba and explained that due to these changes Leonard Harapiak has been asked to stay on as Board Chair for another year. Leonard will continue to provide stability and knowledge that will facilitate forward momentum during this time of transition.

Cordella Friesen and Doug Lauvstad provided an update on the Northern Trades Training Program. Manitoba Hydro has given \$3 million towards the new training program and this cost will be matched by the Government of Manitoba. The Northern Manitoba Sector Council will work with selected apprentices on skills upgrading and then match them with an employer in various industries in the north. The goal of this program is to create a talent pool in the north in high demand trades. A component of this program will have the apprentices work on the Keeyask site during construction.



There have also been a number of recent initiates to engage youth in the trades. The Building for Tomorrow youth camps give students ages 9-16 an introduction to the trades. Apprenticeship Manitoba is also partnering with the Civil Service Commission for the Public Sector Apprenticeship Training Strategy to provide employment opportunities within government departments for individuals interested in the trades.

The Director of Training Standards asked if the Board would approve two stakeholder meetings to update industry on the national harmonization process and receive feedback on recommendations from the Canadian Council of Directors of Apprenticeship (CCDA). These meetings would focus on the trades of Crane and Hoisting Equipment Operator (Mobile Crane) and Carpenter, which are two out of the ten trades being assessed for the harmonization of apprenticeship and certification requirements. The CCDA Harmonization Task Force is a cross jurisdictional committee seeking harmonization across ten Red Seal trades, and will be making recommendations based on an analysis of current requirements as well as stakeholder consultations.

# **Boilermaker**

The PSSC recommends to the Board the acceptance of the Boilermaker Regulation updates in principle as the standard for the trade of Boilermaker.

the trade of Boilermaker, with a recommendation that the Legislative Drafter consider if the scope of the trade accurately reflects the NOA for the trade of Boilermaker.

### Hairstylist

The PSSC recommends to the Board the acceptance of Hairstylist Technical Training Profile and Level Chart as the standard of technical training for the trade of Hairstylist. The PSSC also recommends to the Board the acceptance of the proposed Regulation for the trade of Hairstylist, and notes that the PSSC did not accept the PAC's recommendation to change the apprentice wages for Level 1 and Level 2.

The Board discussed the PAC's recommendation to lower apprentice wages in the trade of Hairstylist for Level 1 and Level 2. It was discussed that lowering apprentice wages is in conflict with the majority of consultation responses, and that maintaining the minimum wage rates for Hairstylist is in keeping with the Board's mandate to consider the interests of all parties in the decision-making process. The Board also discussed that if the issue is one of quality training, that this will be reviewed as a separate issue.

# Minor Changes to Program Standards - policy

A policy has been drafted that will allow the Board to approve minor changes to program standards without necessitating a review by the Provincial Advisory Committee (PAC) for the relevant trade. Recommendations must be taken to the Program Standards Standing Committee for a review to determine if a change requires a PAC or if the recommendation for change can be taken to the Board. This policy is to allow for minor changes to program standards, such as when a provincial exam is changed to an interprovincial exam; or if a new unit is introduced for all trades. Such changes will not be added to the strategic plan, but the Board's annual report will reflect changes. The policy will be applied with discretion.
