2. PROGRAM STANDARDS

2.1 Review CHEO Consultation Responses

Closed.

The PAC reviewed the responses from the December 23, 2016 - January 20, 2017 CHEO Consultation. Three responses were received. One response raised concerns that the proposed trade regulation would prohibit Manitoba tow truck companies from practicing certain tasks listed in the trade regulation. The CHEO PAC revisited section five ('exclusions') of the proposed trade regulation and reaffirmed the recommendation that the tasks written in section five are identified in the scope of the CHEO trade and should be carried out by a journeyman and or an apprentice (who is under the supervision of a journeyman).

The PAC determined to recommend section five ('exclusions') as written.

The second response suggested revisions to the definition of Boom Truck Operator, Mobile Crane Operator, Tower Crane Operator, and to the supervision of apprentices.

The third response was not related to trade regulation or technical training update.

At the December 02, 2016, the PAC inquired if a demonstration clause could be added to the CHEO trade regulation. It was determined that a demonstration clause would not be required as the trade regulation only applies to individuals who are working in the trade.

The Chair provided information to the PAC about the Program Standards Standing Committee meeting he attended on January 31, 2017 to discuss the PAC's recommendations.

The PAC reviewed each section of the proposed trade regulation and made minor revisions that will be incorporated into the document.
