

### 2.1 Review Consultation Guide Comments

The Plumber PAC held a consultation from May 11, 2018 to June 01, 2018. Two responses were received. One of the two comments received were in favour of the proposed technical training standards. The second comment received suggested that the PAC add roll groove to number 16 in Unit A5a Steel Piping. It was noted that threading and grooving as well as roll groove appeared in other pipe fitting Units within the general Unit A5 Pipe Preparation and as such PAC members considered this concern addressed as part of their review of Level One training. The PAC decided to make its final recommendation to the Program Standards Standing Committee.

The PAC was informed that after a lengthy review and thorough consideration, the Minister of Education and Training (Minister) reviewed the industry's request to designate Plumber as a compulsory trade and did not approve the request. The PAC was informed that a three-year moratorium is in place, before future Plumber compulsory designation requests will be considered.

PAC members asked that the committee receive additional information on how the decision was made within one month. The PAC was informed that the feasibility study and all briefing materials are internal documents and likely cannot be shared with the PAC. Apprenticeship Manitoba staff will provide the PAC with more information following a discussion with branch management.
