Health Canada is exploring the introduction of a mandatory program concerning the use of recycled plastic in food packaging. At this time, packaging materials intended for use with food may be voluntarily submitted to Health Canada for a chemical safety assessment. However, Health Canada is looking to make these submissions mandatory. This is in conjunction with efforts to improve circularity within the plastics and packaging economy.
