Search Tool for New Regulatory References Following Regulatory Amendments to Food and Drug Regulations

On Dec. 18, 2024, the Government of Canada published the <u>Regulations Amending Certain</u> Regulations Concerning Food Additives and <u>Compositional Standards</u>, <u>Microbiological Criteria</u> and <u>Methods of Analysis for Food</u> in the Canada Gazette, Part II. These regulatory amendments made changes to the <u>Food and Drug Regulations</u> to provide a more responsive and adaptable regulatory framework for food compositional standards.

In addition to the <u>summary of changes</u> that helps stakeholders navigate the new regulatory framework, a <u>search tool</u> is now available to compare the old and new locations of the regulatory references.

MARKET ACCESS SECRETARIAT (MAS) NOTIFICATIONS

U.S. Food and Drug Administration (FDC) Announcement

The MAS at Agriculture and Agri-Food Canada (AAFC) would like to inform you that on Jan. 16, 2025, the U.S. FDA issued a proposed rule that, if finalized, would require the display of front-of-package (FOP) nutrition information on most foods bearing a nutrition facts label. The rule would require the display of a compact information box containing certain nutrient information on the principal display panel.

European Union Deforestation Regulation (EUDR) Update- Country Classification List

The European Commission published the EUDR benchmarking country classification list. Canada has been classified as a low-risk country. Sourcing from

low-risk countries allows for simplified due diligence obligations for operators and traders. This means that they must collect information on products being imported and/or placed on the market (see EUDR Articles 9 and 13) but are not required to assess and mitigate risk (Articles 10 and 11). It also reduces the extent of compliance checks that Member States' competent authorities must undertake to one per cent of product imports (Article 16).
