# **Executive Summary**

The agri-food sector is vital to the United States (U.S.) economy, influencing both domestic and international markets. As globalization and trade evolve, understanding the competitive landscape of agri-food products is crucial. This analysis provides an overview of U.S. agri-food imports, highlighting key trends and growth patterns on selected products. By examining import data and compound annual growth rates (CAGR), it provides insights into how Canada and Manitoba compare to their competitors in the US agri-food import market.

In 2024, U.S. agri-product imports reached a record \$331 billion, with the top five suppliers being Mexico, Canada, Italy, Brazil, and China. The U.S. is Manitoba's top agri-food trade partner, with \$4.3 billion in exports to the U.S. and \$1.9 billion in imports to Manitoba in 2024. Over the past decade, the U.S. accounted for 46 per cent of Manitoba's agri-food exports and 86 per cent of its agri-food imports. Manitoba agri-food exports to the U.S. have grown at an annual rate of 4.5 per cent in value over the past decade.

In 2024, Manitoba exported \$1.04 billion of canola oil and \$308 million worth of canola meal. Other top exports included prepared potatoes (\$771 million), pork (\$247 million), and oat products (\$185 million). A significant portion of Manitoba's canola oil (94 per cent) and canola meal exports (100 per cent) are destined for the U.S., indicating a strong reliance on this market. The U.S. also imports 95 per cent of Manitoba's prepared potato exports in value, including frozen fries, with five per cent going to Mexico. All of Manitoba's cattle exports and 98 per cent of hog exports (mainly feeder hogs) were shipped to the U.S. in 2024. Additionally, 73 per cent of Manitoba's oats and 98 per cent of oat products are exported to the U.S. Wheat and pork are also significant Manitoba exports, with a considerable share going to the U.S. and other countries, reflecting a diversified approach.

# **U.S. Top Global Agri-food Imports**

In 2024, the U.S. faced a global trade deficit of agri-food products of \$87.5 billion, with exports valued at \$243.7 billion and imports at \$331.2 billion. As shown in Table 1, U.S. global imports rose by \$104 billion between 2020 and 2024, reflecting a CAGR of 9.9 per cent. Specifically, the U.S. had a \$17.2 billion trade deficit with Canada and a \$1.9 billion trade deficit with Manitoba in agri-food products in 2024. Over the last five years, Manitoba's agri-food exports to the U.S. grew by 10.8 per cent.

From 2020 to 2024, the top 20 U.S. agri-food imports included food preparations, beer, bread, pastry and cakes, coffee, frozen shrimps, wine, spirits, fresh beef, frozen beef, fresh avocados, tomatoes, salmon, sugar confectionery, bananas, canola oil, waters, grapes, live cattle, fresh fruits and sweet biscuits. These imports constituted 35.4 per cent of the total import value during this period. Canola oil saw the highest increase in value at 36.7 per cent, while water was the only product to decline, dropping 9.08 per cent. Spirits, sugar confectionary, sweet biscuits, and fresh salmon had CAGR of 22.2, 18.1, 17.5, and 15.3 per cent, respectively.

In 2023, U.S. consumer expenditure on food and non-alcoholic beverages totaled \$1,550 billion, with \$1,374 billion spent on food. Meat was the largest category at \$297.9 billion, followed by bread and cereals at \$248.9 billion, and milk, cheese, and eggs at \$149.6 billion.

Looking ahead, consumer expenditure on food and non-alcoholic beverages is projected to grow at a CAGR of 3.5 per cent from 2023 to 2028. Bread and cereals, along with oils and fats, are expected to grow the fastest at a CAGR of 4.0 per cent, reaching \$302.1 billion and \$45.3 billion, respectively by 2028. All subcategories are anticipated to grow steadily at a CAGR of 2.5 per cent to 4.0 per cent.

In the alcoholic beverages and tobacco category, expenditure on wine is projected to grow the fastest at a CAGR of 4.5 per cent, followed by spirits and beer, both with a CAGR of 3.7 per cent between 2023 and 2028.

In 2024, Mexico was the largest supplier of U.S. agri-food imports, accounting for 20.8 per cent of the total value, followed by Canada (18.7 per cent), Italy (3.8 per cent), and Brazil (3.4 per cent). Other important suppliers include China, France, Chile, India, Indonesia and Australia.

# Manitoba's Top Agri-Food Exports to the U.S.

Exports to the U.S. are crucial for Manitoba's economy. In 2024, Manitoba exported \$4.3 billion worth of agriculture and agrifood products to the U.S, as shown in Table 3. The canola sector led with \$1.3 billion in canola oil and meal combined. Processed potatoes totaled over \$770 million. The hog sector, including pork and live swine, accounted for \$458 million. Oat product exports to the U.S. were valued at \$185 million. These sectors collectively made up more than 64 per cent of the \$4.3 billion in agri-product exports to the U.S. Each sector's market share among overall U.S. imports will be discussed in more detail below.

#### Canola Oil

In 2024, the U.S. imported 3.4 million tonnes of canola oil, valued at \$5.9 billion (Table 4). Although the volume of imports has steadily increased, the total import value in 2024 declined from the record \$6.6 billion in 2023, due to falling canola prices. Canada remains the dominant supplier, accounting for 97.8 per cent of the import value between 2020 and 2024, with a CAGR of 45.6 per cent. Manitoba contributed 18 per cent of Canada's total export value to the U.S. in 2024, with a CAGR of 15.5 per cent for imports originating from the province.

#### **Processed Potatoes**

In 2024, the U.S. imported \$3.8 billion worth of processed potatoes (Table 5). Over the past five years, these imports grew at a CAGR of 23.7 per cent. The primary suppliers were Canada (78.5 per cent), Belgium (9.5 per cent), Mexico (5.2 per cent), and the Netherlands (2.3 per cent). Manitoba's processed potato exports to the U.S. had a CAGR of 12.7 per cent, lagging Canada's national rate of 21.8 per cent. Imports from Belgium showed significant growth, with a CAGR of 43.9 per cent, reaching \$409 million in 2024.

Despite increased competition, the U.S. remains heavily reliant on Canada for processed potato supply. Manitoba accounted for 29 per cent of the total U.S. import value from Canada between 2020 and 2024. This trade relationship is vital, with over 95 per cent of Manitoba's processed potato exports heading to the U.S., and Manitoba supplying nearly one-third of U.S. processed potato imports.

#### Canola Meal

Between 2020 and 2024, the U.S. imported canola meal worth \$8.3 billion, with a CAGR of 15.6 per cent. The volume of imports steadily increased year-over-year, reaching a record 3.8 million tonnes in 2024. Canada, nearly the exclusive supplier of canola meal to the U.S., accounted for 99.2 per cent of the import value during this period, as shown in Table 6. Manitoba contributed nearly 20 per cent of the total U.S. imports.

#### **Pork**

In 2024, U.S. pork imports peaked at \$2.1 billion, with a CAGR of 9.9 per cent from 2020 to 2024, as shown in Table 7. Canada was the main supplier, accounting for 62.1 per cent of the total import value, followed by Mexico (9.5 per cent), Denmark (8.7 per cent), Brazil (4.7 per cent), Poland (4.2 per cent), and Spain (2.3 per cent). Spain and Brazil had the highest CAGRs during this period, at 53.5 per cent and 29.9 per cent, respectively. Manitoba contributed 19 per cent of the pork imports from Canada, equating to 12 per cent of the total U.S. pork imports from 2020 to 2024. The U.S. market comprises 23 per cent of Manitoba's pork exports, with other key destinations including Japan, South Korea, Mexico, China, and the Philippines.

#### Live Swine

In 2024, the U.S. imported 6.8 million heads of live swine from Canada, valued at \$779 million, as shown in Table 8. These imports have grown steadily from 5.3 million heads in 2020, reflecting a CAGR of 22.1 per cent from 2020 to 2024. Manitoba contributed \$228 million worth of swine, representing 29 per cent of the total imports and 37 per cent of the pigs sold by the province. Given the deep integration of the Canadian and U.S. hog industries, it is unlikely another supplier could take Canada's place, even under tariff conditions.

#### **Oat Products**

Over the past five years (2020–2024), the U.S. imported oat products worth \$3 billion, with a CAGR of 14.5 per cent, as shown in Table 9. Imports peaked in 2022, with a value of \$794 million and 0.6 million tonnes. Canada was the primary supplier, accounting for 95.5 per cent of total U.S. oat product imports. Manitoba contributed 26.4 per cent of these imports. Like processed potato products, oat products are generally lower-cost staple foods and so likely have inelastic consumer demand, making trade more resilient in the face of potential tariffs.
